On May 24, 1984, the Commission, pursuant to OTHER PERTINENT INFORMATION: the provisions of the CEQA, considered and adopted a Proposed Negative Declaration (ND 358, State Clearinghouse No. 84020113), for the program under which issuance of this parmit is proposed, the Commission found, based on its record, that there is no substantial evidence that the program, as revised and approved, will have a significant effect on the environment (14 Cal. Adm. Code 15074(in)).

This activity involves lands identified as possessing significant environmental values pursuant to P.R.C. 6370, et seq. Based upon the staff's consultation with the persons Foundnating such lands and through the CEQA review process, it is the staff's opinion that the permit as part of the program for the project, as proposed, is consistent with its use classification.

# IT IS RECOMMENDED THAT THE COMMISSION:

- DETERMINE THAT ON MAY 24, 1984, A NEGATIVE DECLARATION, ND 358, STATE CLEARINGHOUSE 84020113, WAS CONSIDERED AND ADOPTED FOR THE PROGRAM UNDER WHICH ISSUANCE OF THIS PERMIT IS PROPOSED PURSUANT TO THE PROVISIONS OF THE CEGA AND THAT THE COMMISSION HAS REVIEWED AND CONSIDERED THE INFORMATION CONTAINED THEREIN AND THE COMMENTS IN THE COMMISSION'S FILES WHICH WERE RECEIVED IN RESPONSE THERETO.
- DETERMINE THAT THERE IS NO SUBSTANTIAL EVIDENCE THAT THE PROGRAM UNDER WHICH ISSUANCE OF THE PERMIT AS PROPOSED, AS REVISED AND APPROVED, WILL HAVE A SIGNIFICANT EFFECT ON THE ENVIRONMEN .
