SUMMARY:

Issuance of Royalty Oil Sales Contract PRC 6533.1 to Paramount Petroleum's predecessor in interest, Pacific Oasis, for a term of 18. months commencing July 1, 1984 was authorized by the Commission on December 22, 1983. The contract was based on competitive public bid (nine bidders) with bonus bids in dollars per barrel above the base price. The base price is the highest price posted for oil of like gravity and quality in the South Elwood Offshore Field on the day of the delivery. Pacific Oasis was the highest responsible bidder with a bid of \$2.155. In March of 1984, Pacific Oasis changed its business organization from a General Partnership to a Corporation and adopted the name Paramount Petroleum. All of the assets of Pacific Oasis were transferred to the new corporation including the Royalty Oil Sales Contract with the State. The existing bond and insurance policy called for by the contract which protects the State, were also put into Paramount's name.

On June 23, 1984, just prior to the beginning date of the Royalty Oil Sales Contract, certain creditors of Paramount Petroleum filed an involuntary Chapter 11 bankruptcy petition against Paramount under the bankruptcy act. This involuntary bankruptcy has since been

changed to a voluntary one. No royalty cil has been delivered to Paramount under this contract. Paramount Petroleum new desires to assign the Royalty Oil Sales Contract for its entire term to P.R.I. of Hawaii, Inc., and has submitted a non-conditional assignment and assumption of contract form effective July 1, 1984 for State Lands Commission approval.

PREREQUISITE ITEMS:

Assignment forms have been executed by assignor and assignee and are on file in the Long Beach office of the State Lands Cormission.
