Edgington Oil Company, Inc. 2400 East Artesia Boulevard Long Beach, California 90805

Issuance of Royalty Oil Sales Contract PRC 6497 to Paramount Petroleum's predecessor in interest, Pacific Oasis, for a term of 18 months commencing December 1, 1983 was authorized by the Commission on September 28, 1983. The contract was based on competitive public bid (11 bidders) with bonus bids in dollars per barrel above the base price. The base price is the highest price posted for oil of like gravity and quality in the Huntington Beach Field on the day of the delivery. Pacific Oasis was the highest responsible bidder with a bid of \$2.057. In March of 1984, Pacific Oasis changed its business organization from a General Partnership to a Corporation and adopted the name Paramount Petroleum. All of the assets of Pacific Oasis were transferred to the new corporation including the Royalty Oil Sales Contract with the State. The existing bond and insurance policy called for by the contract which protects the State, were also put into Paramount's name,

On June 23, 1984, certain creditors of Paramount Petroleum filed an involuntary Chapter 11 bankruptcy petition against Paramount under the bankruptcy act. This involuntary bankruptcy has since been

changed to a voluntary one. On June 27, 1984 Paramount defaulted on payment due to the State for May 1984 royalty oil deliveries. They have also informed staff that no payment will be made for June 1984 deliveries. The State's claim is now being processed against the bond. No loss is anticipated.

Paramount Petroleum now desires to assign the Royalty Oil Sales Contract for its remaining term to Edgington Oil Company, Inc. and has submitted a non-conditional assignment and assumption of contract form effective July 1, 1984 for State Lands Commission approval.

Assignment forms have been executed by assignor and assignee and are on file in the Long Beach office of the State Lands Commission.
