BACKGROUND:

On July 12, 1984, the State Lands Commission approved the issuance of a General Lease – Commercial Use, covering a 4.875-acre parcel of tide and submerged land in the Sacramento River, Sacramento County, for construction and maintenance of a commercial marina, to Riverbank Holding Company.

CURRENT SITUATION:

Lessee has applied to Sacramento Savings and Loan Association and First Federal Lincoln for a loan to construct the facilities authorized under lease PRC 6427.1. As a condition for the loan, Sacramento Savings and Loan Association and First Federal Lincoln have requested that they be named as a secured party-lenders under the subject lease. Lessee, Sacramento Savings and Loan Association and First Federal Lincoln have signed the Agreement and Consent to Encumbrancing Lease and said document is on file in the offices of the State Lands Commission.


IT IS RECOMMENDED THAT THE COMMISSION:
