APPROVAL OF MODRING SITE SUBLEASE FORM PRC 3639.1

LESSEES:

BACKGROUND:

On December 16, 1982, the State Lands Commission awarded Lease PRC 3639.1, as amended by the Supplemental Agreement to Lease PRC 3639.1 effective January 1, 1984, to the Santa Catalina Island Company and the Santa Catalina Island Conservancy as Lessees. The Lessees have delegated management of the lease premises, with the Commission's approval, to Doug Bombard Enterprises. The lease is a 15-year lease which will expire December 31, 1996. The current annual rental is \$206,500. The lease presently authorizes 720 revenue-producing moorings and two revenue-producing stringlines. The State's lease provides that subleases of individual mooring sites shall be issued by a standard form previously approved by the State.

CURRENT SITUATION:

The Lessee's operator, Doug Bombard Enterprises, currently subleases individual mooring sites pursuant to two standard forms:

1. Mooring Site and Equipment Sublease and Service Contract (mooring equipment is not owned by sublessee, but is leased from Doug Bombard Enterprises); and

2. Mooring Site Sublease and Service Contract (mooring equipment is owned by sublessee, but serviced by Doug Bombard Enterprises). Lessee's operator proposes to amend these forms for purposes of clarification, and to include itself with the State and the State's Lessee, in hold harmless, indemnification, and force majeure provisions of the sublease documents.

Lessee also proposes a third sublease form, Mooring Site Sublease and Service Contract — Non-Transferable. This form is similar in content to (2) above except that it prohibits the transfer of any right or interest in the sublease because the right to make one transfer of the sublease after March 1, 1982, as provided in the State's lease, has already been exercised. The three proposed forms as modified are on file in the office of the State Lands Commission. The proposed forms are consistent with the terms and conditions of Lease PRC 3639.1.
