OTHER PERTINENT INFORMATION:

- 1. The applicant proposes to dock the Delta King, a historic vessel, at River Lines Pier, in Sacramento, to perform needed renovation of the vessel's superstructure.
- 2. The staff has informed the applicant that 24-hour onboard security is a condition of the lease, and that the applicant must arrange fire and police protection services with the City of Sacramento. The applicant is discussing those matters with the City of Sacramento. The lease would be conditioned on meeting public safety, liability and sanitation requirements.
- 3. The lease also includes a special provision which will allow either party to terminate the lease upon giving a 30-day notice.
- 4. This activity involves lands identified as possessing significant environmental values pursuant to P.R.C. 6370, et seq. but will not affect those significant lands.
- 5. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (14 Cal. Adm. Code 15061), the staff has determined that this activity is exempt from the requirements of the CEQA s a categorical exempt project. The prect is exempt under Class 1, existing facilities, 14 Cal. Adm. Code 15301.

 RESERVING THE RIGHT TO TERMINATE THE PERMIT UPON 30 DAYS'
 NOTICE.
