In addition to the boat repair and boat hanbor uses, the State's land is improved with an existing restaurant operation and a Sea Scout facility. Crockett Marine Service anticipates sublease agreements with the restaurant operator and the Sea Scouts subsequent to the approval of the assignment and amendment ions presented herein. The sublease agree is will be presented to the Commission in approval after they have been drawn up.

3. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (14 Cal, Adm, Code 15061), the staff has determined that this activity is exempt from the requirements of the CEQA as a categorical exempt project. The project is exempt under Class I, existing facilities 2 Cal. Adm. Code 2905(a)(2).

4. The land area subject to rental hercin includes an approximate 5.03 core portion presently unimproved, except r an existing Sea Scout shed. Crockett Marine Service has agreed to quitclaim said area, excepting that part occupied by the Sea Scout facility, if it fails to submit an application to the Commission, on or before August 20, 1986, and to all other permitting jurisdictions, providing for a specific pian to construct lawful improvements in the unoccupied portion.

This activity involves lands identified as possessing significant environmental values pursuant to P.R.C. 6370, et seq. but will not affect those significant lands.

Those certain State-owned tide and submerged lands, situated in the County of Contra Costa, State of California, more particularly described as follows:

COMMENCING at a monument formerly set and marked by the California and Hawaiian Sugar Company as No. 258, but since adopted by the United States Army Engineers as their Harbor Line Monument No. 33, and so marked by them on a brass plate set in the concrete filling of a six inch pipe, and shown on that certain map entitled "Harbor Lines for Carquinez Strait, California", dated June 10, 1924, and marked File 4, Div. 4, Sheet 6, which said Harbor Line Monument and point of commencement is located 435.28 feet North and 254.71 feet Fast of the commen common to Sections 21 and 20 Table 20 East of the corner common to Sections 31 and 32, T3N, R3W, MDM, and Sections 5 and 6, T2N, R3W, MDM, said corner common to said Sections 31, 32, 5 and 6, being marked by a point in a bronze plate set in the top of a concrete pyramid approximately 10 feet high resting on piles driven into the earth, thence N 83°15'30"W 255.96 feet to a point; thence due North 145.66 feet to a point on the United States Bulkhead Line of 1883; thence N 89°03'15"W along the said United States Bulk-head Line of 1888, 536.35 feet to the TRUE POINT OF BEGINNING of this description, said true point of beginning bears 617.44 feet North and 536.28 feet West of the aforesaid Section Corner common to Sections 31, 32, 5 and 6, thence due North 462.81 feet to a point in the waters of Garquinez Strait located on the United States Bulkhead Line as shown on the aforesaid map entitled "Harbor Lines for Carquinez Strait, California"; thence N 87°07'22"W along said United States Bulkhead line 927.72 feet to a point, thence S 7°40'W 468.06 feet to a point on the northerly right-of-way wine of the Southern Pacific Railroad Company, thence S 83°14'45"E along the said northerly right-of-way line of the Southern Pacific Railroad Company 257.58 feet to a point; thence continuing along said northerly right-of-way line of the Southern Pacific Rail-road Company which right-of-way line is also the United States Bulkhead Line of 1888, S 89°03'15"E 684.46 feet more or less to the true point of beginning and containing 10.0 acres of land more or less.
