- The Warm Springs Road Bridge has been in use for many yeary; the current proposal is to replace it with a new structure on the same autogment.
- 2. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (14 Cal. Adm. Code 15061), the staff has determined that this activity is exempt from the requirements of the CEQA as a categonical exempt project. The project is exempt under Class 2 replacement or reconstruction, 14 Cal. Adm. Code 15302.
 - Authority: P.R.C. 21084 and 14 Cal. Adm. Code 15000
- 3. The annual rental value of the site is estimated to be \$100.00.
 - This activity involves lands which have NOT been identified as possessing significant environmental values pursuant to P', R. C. 6370, et seq. However, the Commission has declared that all tide and submerged lands are "significant" by nature of their public ownership (as opposed to "environmental significant"). Since such declaration of significance is not based. upon the requirements and criteria of P.R.C. 6370, et seq., use classifications for such lands have not been designated. 
