OTHER PERTINENT INFORMATION:

- 1. The Poleta Road Bridge has been in use for many years; the current proposal is to replace it with a new structure on the same alignment.
- Pursuant to the Commission's delegation of authority and the State GEQA Guidelines (14 Cal. Adm. Code 15061), the staff has determined that this activity is exempt from the requirements of the CEQA as a categorical exempt project. The project is exempt under Class 2, replacement or reconstruction, 14 Cal. Adm. Code 15302.

Authority: P.R.C. 2/804 and 14 Cal. Adm. Code 15300.

- The annual rental value of the site is estimated to be \$100.
- 4. This activity involves lands which have NOT been identified as possessing significant environmental values pursuant to P.R.C. 6370, et seq. However, the Commission has declared that all tide and submerged lands are "significant" by nature of their public ownership (as opposed to "environmental significant"). Since such declaration of significance is not based upon the requirements and criteria of P.R.C. 6370, et seq., use classifications for such lands have not been designated. Therefore, the finding of the project's consistency with the use classification as required by 2 Cal. Adm. Code 2954 is not applicable.

EXCEPTING THEREFROM any portion lying landward of the ordinary low water mark of the Owens River.


