EXCHANGE OF MINERAL RIGHTS NEAR  
DOYLE, LASSEN COUNTY

The Wildlife Conservation Board has entered into a land exchange involving the State parcel, described generally in Exhibit A -1, and a private parcel, described generally in A - 2, owned by J.H. and R.G. Senarosa, husband and wife. The parcels are located near Doyle in Lassen County. In this exchange the state WCB will acquire property that is more strategically located within the plan of the Doyle Winter Range Project. In the course of completing the transaction it became apparent that the Wildlife Conservation Board only had control of the surface rights on the State parcel, and that the State Lands Commission retained the mineral rights.

PRC 7303.5 authorizes the State Lands Commission to exchange mineral rights, in the land conveyed if it receives the mineral rights in the lands acquired. Therefore, in this case it will be necessary for the Wildlife Conservation Board to exchange the surface right, and the State Lands Commission the mineral rights. The mineral rights acquired shall have the same status as to administration, control and disposition as the lands conveyed.

Mineral valuations have been conducted by the staff of the Commission and it has been concluded that the mineral value of the prospective exchange parcels are equal.

CALENDAR ITEM NO. (CONT'D)

Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (14 Cal. Adm. Code 15061), the staff has determined that this activity is exempt from the requirements of the CEQA under the general rule that CEQA applies only to projects which have the potential for causing a significant effect on the environment. The staff believes there is no possibility that this project may have a significant effect on the environment.

3. AUTHORIZE THE CONVEYANCE BY PATENT OF MINERAL RIGHTS IN THE STATE LAND DESCRIBED GENERALLY ON EXHIBIT "A - 1", ATTACHED, AND BY REFERENCE MADE A PART HEREOF, TO J.H. SENAROSA, AND R.G. SENAROSA, HUSBAND AND WIFE.
4. AUTHORIZE THE ACCEPTANCE AND CONSENT TO RECORDATION OF A DEED TO THE STATE FOR MINERAL RIGHTS IN THE PARCEL DESCRIBED ON EXHIBIT "A - 2", ATTACHED, AND BY REFERENCE MADE A PART HEREOF.

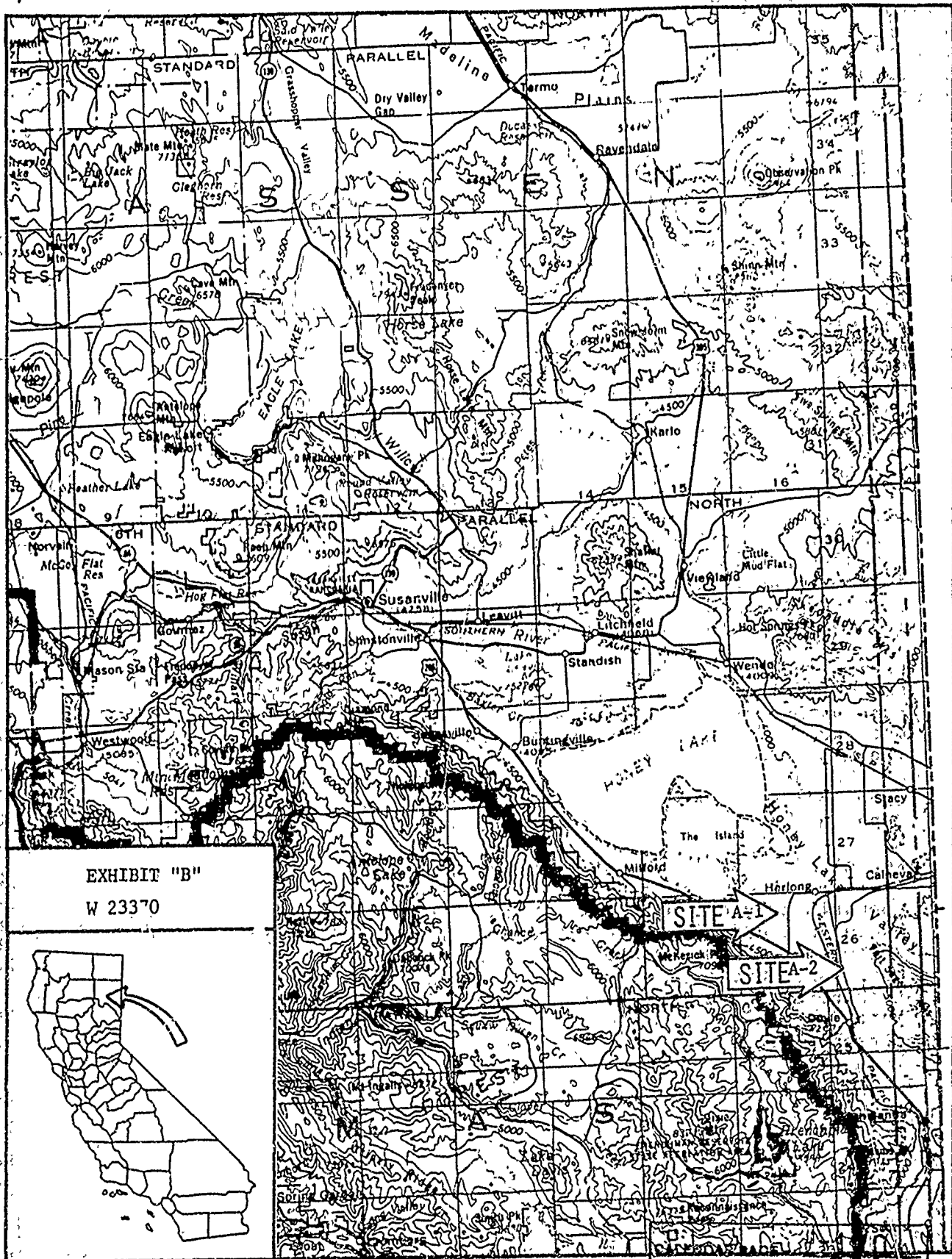
