ISSUANCE OF AMENDED PATENT - LEON FINK

In 1968, suit to quiet title to the SE-1/4 of the SE 1/4 of Section 28, T5N, R12W, SBM, Los Angeles County, listed to the State of California as lieu lands, was instituted against the late Leon Fink by the State Lands Commission. In settlement of the litigation, the Commission agreed in 1979 to accept the sum of \$50,000 in exchange for a patent of the property to "Richard L. Fink, Executor of the Estate of Leon Fink, Deceased."

Richard L. Fink, Executor of the Estate of Leon Fink and Jacob Forst, attorney to the late Mr. Fink have now requested that the Commission issue a new, amended patent to "Richard L. Fink, Executor of the Estate of Leon Fink, Deceased, Richard L. Fink, Trustee, and Jacob Forst, Trustee, as their interests may be."

The staff and the Attorney General's Office believe that this request is a reasonable one and that a new patent be issued as noted above.

This activity is not a "project" as defined by CEQA and the GEQA Guidelines.

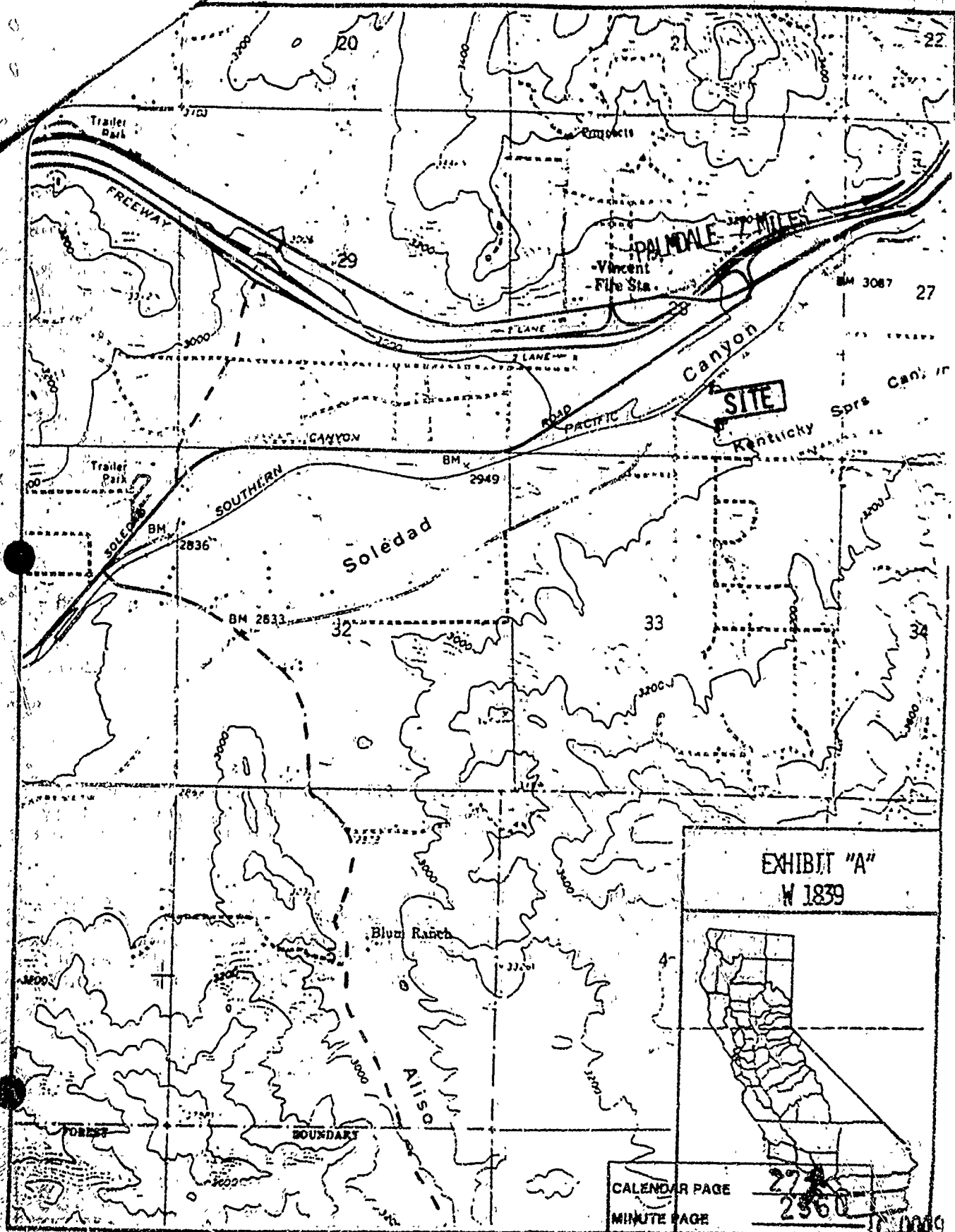
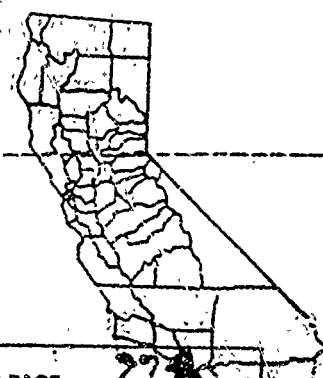
