#### OTHER PERTINENT INFORMATION:

- 1. On September 5, 1984 the Executive Officer issued a Letter of Permission to the United States Bureau of Reclamation (Bureau) for bank protection work along Snodgrass slough, Sacramento County. As a condition to the Letter of Permission the Bureau must obtain a General Permit Public Agency Use as soon as possible. This calendar item reflects said condition.
- 2. Due to minimum staff time required for this transaction, staff recommends all processing fees be walved.
- 3. The annual rental value of the site is estimated to be \$335.
- 4. This activity involves lands identified as possessing significant environmental values pursuant to P.R.C. 6370, et seq. project, as proposed, is consistent with its use classification.
- Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (44 Cal. Adm. Code 15061), the staff has determined that this activity is exempt from the requirements of the CEQA as a categorical exempt project. Class 4, minor alterations to Tand 2 Cal. Adm. Code 2905(d)(2).
