AMENDMENT TO EXISTING DREDGING PERMIT FROM 15,000 CUBIC YARDS TO 21,000 CUBIC YARDS

LAND USE;

5E: Dredge up to 21,000 cubic yards of material to reestablish a navigational channel to the launch ramp and docks in the marina.

RESUME OF PREVIOUS ACTION

The Commission on September 25, 1984, authorized issuance of Dredging Permit PRC 6736 to the applicant, City of Vallejo, effective October 1, 1984 for dredging of 15,000 cubic yards of sediments from the Vallejo Municipal Marina to reestablish a navigation access channel to the launch ramp and docks in the marina harbor. Spoils disposal is at the Corps of Engineers approved disposal site S.F. 9 in the Carquinez Strait with the \$0.15 royalty waived as the project is in the public interest.

PROPOSED MODIFICATION:

Increase the permitted dredging volume of 15,000 cubic yards an additional 6,000 cubic yards to 21,000 cubic yards to allow for an underestimated initial amount brought on by excessive siltation from last winter's floods and activity at adjacent shipyards during construction of a platform jacket. The boat

traffic from the project caused silting up of adjacent harbors and dockage. All other terms and conditions of the existing permit, PRC 6736 are to remain unchanged.

CONSIDERATION:

: To facilitate continued dredging of the designated area by allowing for the 6,000 yard increase which will permit the removal of excessive siltation brought on by storms and excessive boat traffic which contributed to the siltation.

- This activity involves lands identified as possessing significant environmental values pursuant to P.R.C. 6370 et seq. 





The permission to dredge the above-described lands is based upon information presently available to the State Lands Commission, and is given without survey or title determination. Such permission shall not be construed as fixing State land boundaries nor as necessarily establishing the extent of the State's claim to property in the area. The State warrants neither the title to the demised premises nor any right you may have to possession or quiet enjoyment of the same.

It is hereby agreed that the operations authorized under this permit shall be performed with diligence, in a good and workmanlike manner, and with the use of due care and safety precautions.

It is further agreed that you shall submit reports substantiating the volume of materials dredged and any royalties due to the Comission on a guarterly basis, on forms " supplied by the Commission (Form 30.9 NC). It is agreed that you shall submit said forms on or before the fifteenth (15th) day of the month following the end of each permit quarter together with payment for the royalty due on the volume removed during that quarter. The first permit quarter shall be the first three months following the effective date of this permit, and every three-month period thereafter shall be a permit quarter.

It is hereby agreed that, pursuant to Public Resources Code Section 6224, any installments of royalty accruing under the provisions of this permit that are not paid when due shall be subject to a five percent (5%) penalty and shall bear interest at the rate of one and one-half percent (1-1/2%) per month from the date when the same was payable by the terms hereof.

It is agreed that you shall furnish the Commission with copies of final surveys or copies of any other computations used as a basis to verify dredge volumes within twenty-five (25) days of completion of the activity authorized hereunder.

It is agreed that you shall indemnify, save harmless and, at the option of the State of California, defend said State, its officers, agents and employees, against any and all claims, demands, causes of action, or liability of any kind which may be asserted against or imposed upon the State of California or any of its officers, agents or employees by any third person or entity, arising out of or connected with the issuance of this permit, operations hereunder, or the use by you or your agents, employees or contractors, of the above described lands.
