FIFTH MODIFICATION OF THE 1984-1985 PLAN OF DEVELOPMENT AND OPERATIONS AND BUDGET, LONG BEACH UNIT, WILMINGTON OIL FIELD, LOS ANGELES COUNTY

The City of Long Beach has submitted to the Commission and requested approval of the Fifth Modification of the 1984-1985 Flan of Development and Operations and Budget, Long Beach Unit. This modification would modify the Plan and Budget to provide for the purchase of ten replacement water injection pump motors. Funding would be by transfer so that the total budget would remain unchanged at \$251,278,000.

Many of the 1500 HP and 1750 HP electric motors on the Unit water injection pumps have been in service 15 to 18 years. Maintenance costs are increasing, and even though these motors have been adequately maintained, their efficiency has slowly deteriorated. New motors built with today is technology are more efficient from the start and in some cases will qualify end of 1985, With the improved efficiencies, lower maintenance cost and available rebates, replacements for the ten motors that currently are the least economical to operate would pay

Estimated cost of the new motors is \$526,000. Funds were not provided in the budget for this project. Funding is available for Budget Item D. 2. 5. (2) Water Injection System, Water Injection Program by transfer from Budget Item C. 1. b. (3) Oilwell, Direct Changes, Caustic Flood, Enhanced Recovery and Stimulation Program. Routine oilwell maintenance has goen considerably less than estimated in the final stages of this
