## BACKGROUND

On January 19, 1981, the State of California, acting by and through the Department of General Services, sold a parcel of property to Auburn Bell Investors. This property was originally a part of the old Dewitt State Hospital.

This sale provided for the reservation of mineral rights, pursuant to P.R.C. Section 6407. The quitclaim deed also diver provided for the exercise of surface entry rights through a designated drill site location and access location.

Auburn Bell Investors subsequently sold the property to Placer Center Executive Office Park, a California limited partenership, which is planning to construct an office complex on the property. The proposed development plan includes the areas originally designated for the drill site and access. The surface owners desire to modify the location for the drill site and access and to provide for different locations for the drill site and access.

The staff has reviewed the proposed new drill site and access loc tions and prepared an agreement (for the modification of the State's surface entry rights. This agreement is contained in Exhibit "C" which is incorporated herein by reference.




