GENERAL PERMIT - PUBLIC AGENCY USE  
(RECREATIONAL PURPOSE)

CO-APPLICANTS: City of Sacramento and  
Sacramento Water Festival Assn.

AREA, TYPE LAND AND LOCATION:

Undetermined acreage, tide and submerged land,  
Sacramento River, Sacramento County.

LAND USE:

Temporary floating dock and 13 floating buoys.

TERMS OF PROPOSED PERMIT:

Total period: One month and 23 days  
beginning May 23, 1985.

CONSIDERATION: The public use and benefit; with the State  
reserving the right at any time to set a  
monetary rental if the Commission finds such  
action to be in the State's best interest.

BASIS FOR CONSIDERATION:

Pursuant to 2 Cal. Adm. Code 2003.

APPLICANT STATUS:

Applicant is owner of upland.

PREREQUISITE CONDITIONS, FEES AND EXPENSES:

Filing fee has been received. Staff recommends  
waiver of the normal processing fee in light of  
the short-term nature of this event, and in  
consideration of its recreational character.

OTHER PERTINENT INFORMATION:

1. This application has been submitted to the Commission in connection with events sponsored by the Sacramento Water Festival Association.

The Sacramento Water Festival is a non-profit entertainment event that incorporates the elements of community-civic water events and competition on the World Point Tour of the International Formula I Grand Prix boat races.

The Festival will take place July 6-7, 1985, on the Sacramento River, south of Tower Bridge to the Pioneer Bridge. Activities include aquatic demonstrations, both on the water and in the air, exciting displays of lights and fireworks, and participant competition in water activities.

Equipment will consist of portable cranes used to put boats in water and temporary docks for boats to start from. The equipment is not permanent and will be removed immediately after the event, leaving the site in its natural condition. The permittee's signs, placards and announcements will include an acknowledgment that the water site for this event have been made available by the State Lands Commission.

2. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (14 Cal. Adm. Code 15061), the staff has determined that this activity is exempt from the requirements of the CEQA as a categorical exempt project. The project is exempt under Class 4, Minor Alterations to Land, 14 Cal. Adm. Code 15304(e).

3. This activity involves lands identified as possessing significant environmental values pursuant to P.R.C. 6370, et seq. but will not affect those significant lands.

IT IS RECOMMENDED THAT THE COMMISSION:

1. FIND THAT THE ACTIVITY IS EXEMPT FROM THE REQUIREMENTS OF THE CEQA PURSUANT TO 14 CAL. ADM. CODE 15061 AS A CATEGORICAL EXEMPT PROJECT, CLASS 4, MINOR ALTERATIONS TO LAND, 14 CAL. ADM. CODE 15304(e).
2. FIND THAT THIS ACTIVITY WILL INVOLVE LANDS IDENTIFIED AS POSSESSING SIGNIFICANT ENVIRONMENTAL VALUES PURSUANT TO P.R.C. 6370, ET SEQ., BUT THAT SUCH ACTIVITY WILL HAVE NO DIRECT OR INDIRECT EFFECT ON SUCH LANDS.
3. WAIVE THE NORMAL PROCESSING FEE.
4. AUTHORIZE ISSUANCE TO THE CITY OF SACRAMENTO AND THE SACRAMENTO WATER FESTIVAL ASSOCIATION, OF A ONE MONTH AND 23 DAY GENERAL PERMIT - PUBLIC AGENCY USE (RECREATIONAL PURPOSE), BEGINNING MAY 23, 1985; IN CONSIDERATION OF THE PUBLIC USE AND BENEFIT, WITH THE STATE RESERVING THE RIGHT AT ANY TIME TO SET A MONETARY RENTAL IF THE COMMISSION FINDS SUCH ACTION TO BE IN THE STATE'S BEST INTEREST; FOR THE TEMPORARY PLACEMENT OF A FLOATING DOCK AND 13 FLOATING BUOYS ON THE LAND DESCRIBED ON EXHIBIT "A" ATTACHED AND BY REFERENCE MADE A PART HEREOF.

## EXHIBIT "A"

## LAND DESCRIPTION

W 21741

All that tide and submerged land in the bed of the Sacramento River, Sacramento and Yolo Counties, California, lying immediately beneath a temporary 4 foot by 180 foot floating dock adjacent to the left bank of said Sacramento River and 13 floating buoys in said river, TOGETHER WITH a necessary use area extending 10 feet from the extremities of said dock and buoys, said dock and buoys being located between the Pioneer and Tower bridges over the Sacramento River.


