OTHER PERTINENT INFORMATION:

- 1. The present lessee, River View Marina, seeks approval for activities to protect the marina and an associated condominium project which would be located within the flood plain between the river and the levee. The work will not enlarge the leased premises nor alter the character of the present marina business. The staff concludes that a rental adjustment of the lease is not applicable.
- The proposed expansion of the marina and the associated condominium development was considered in an environmental impact report (EIR) prepared by the County of Sacramento as CEQA lead agency. The EIR was adopted by the County on April 18, 1984, and findings made that "with the mitigation measures imposed the impacts will be less than significant." The activities to protect the marina and the residential development are referred to in the cited document.

The area supporting the proposed development was subsequently annexed to the City of Sacramento which prepared, in July 1984, a Negative Declaration for the above described project. The City, in preparing the Negative Declaration, "determined that the project, with mitigation measures, as identified in the attached Initial Study, as resolved, will not have a significant effect on the environment." The Negative Declaration was adopted by the City on September 4, 1984. The project is located in the urbanizing Riverfront District of the South Natomas Community Plan (City of Sacramento).

The Commission is a responsible agency for the se activities which are proposed for the State's tide and submerged lands. As a responsible agency, the Commission staff has: (1) determined the extent of environmental analysis as described above; (2) examined the County's ElR and the City's Negative Declaration; and, (3) concluded that they are valid documents under the CEQA.

3. This activity involves lands identified as possessing significant environmental values pursuant to P.R.C. 6370, et seq. Based upon the staff's consultation with the persons nominating such lands and through the CEQA review process, it is the staff's opinion that the project, as proposed, is consistent with its use classification.
