LETTER OF AUTHORIZATION TO DRILL A T.ST BORE

During consideration of Calendar Item 24 attached, Letter of Authorization dates were changed to June 6, 1985 and July 31, 1985 respectively. With that change, the following resolution was approved by a vote of 2-0:

THE COMMISSION:

1. FINDS THAT THE ACTIVITY IS EXEMPT FROM THE REQUIREMENTS OF THE CEQA PURSUANT TO 14 CAL. ADM. CODE 15061 45 A CATEGORICALLY EXEMPT PROJECT, CLASS 6, INFORMATION COLLECTION, 2 CAL. ADM. CODE 2905.

DETERMINE THAT THE PROJECT, AS APPROVED, WILL NOT HAVE A SIGNIFICANT EFFECT ON THE ENVIRONMENT.

- 2. FINDS THAT THE ACTIVITY IS CONSISTENT WITH THE USE CLASSIFICATION DESIGNATED FOR THE LAND PURSUANT TO P.R.C. 6370, ET SEQ.

RESTORING THE TEST PREMISES AS NEARLY AS POSSIBLE TO ORIGINAL CONDITION UPON COMPLETION OF THE TEST.

In 1984, Chevron U.S.A., Inc. initiated a project to install two pipelines, one for wet oil and the other for sour gas, from Chevron's proposed Platform Hermosa, on offshore Federal Lease OCS-P-0316, to a landfall approximately 1.5 miles north of Point Conception. The pipelines were to be installed, using conventional trenching and backhoe methods. An Environmental Impact Statement (EIS) and an Environmental Impact Report (EIR) No. 366 were prepared for the entire project which includes the cumulative development of the South Santa Maria Basin, as well as offshore and onshore pipelines connecting platforms to an oil and gas processing facility at Gaviota, by the County of Santa Barbara and the Minerals Management Service, SCM 8314 0911 and was certified on October 25, 1984.

CURRENT SITUATIONS:

 Chevron has recently investigated a horizontal directionally drilled shore crossing technique as an alternative to the conventional method. The drilled

crossing method has been successful in other areas, but has never been attempted before in the Sisquoc rock formation found at Point Conception.

On April 12, 1985, Chevron contacted the staff of State Lands Commission with a request for authorization to drill a test bore using this new method from shore along the shore crossing route into submerged tide lands. bore would be approximately 3,480 feet long, beginning at a point approximately 880 feet east of the mean high tide line and extending westerly to a point approximately 2,600 feet west of the mean high tide. The test bore would end on the sea floor at an approximate 60-foot water depth as shown on Exhibit "A". Chevron has requested that the test be allowed to start May 28, 1985 and hopes to be completed by July 22 1985. AFter the test hole has been completed, and the substrata along the noute have been investigated. Chevron would determine if a full scale drilled crossing can be accomplished. If the results of the test are unsatisfactory, Chevron proposes to use the conventional constraints shore crossing method.

MARY . MAY

Staff recommends issuing a Letter of Authorization to Chevron to do the test bore.

The Letter of Authorization would allow Chevron to conduct the test only, and would be conditional upon Chevron receiving any other Federal; State, and local approvals that may be required. The Letter of Authorization would require Chevron to plug the drill hole to the satisfaction of State Lands Commission staff, in the event the test is unsuccessful or if the hole is subsequently not used for any reason; and, would require Chevron to restore the lest to the test. Chevron has agreed to apply to the State Lands Commission for a General Lease = Right=of=Way-Use installation.

This activity involves lands identified as possessing significant environmental values pursuant to P.R.C. 6370, et seq. Based upon the staff's consultation with the persons nominating such lands and through the CEQO review process, it is the staff's opinion that the project, as proposed, is consistent with its use classification.
