OTHER PERTINENT INFORMATION:

In May 1984 the Commission approved renewal for a five year period of General Lease -Commercial Use, Lease PRC 745 and General Lease - Public Agency Use, Lease PRC 5254 which provided for one-year rent reviews. As staff attempted to process these rent reviews based on rental rates reflected by current appraisals, opposition to the proposed rent charges was made by the lessee Röbert Hallmark. The City of Trinidad also objected in view of the uncertainty of the fishing season due to restrictions made by the Department of Fish and Game and the Pacific Fisheries Management Council. Staff also received communications from business people in Trinidad stating their concern over the uncertainty of the fishing industry. In an attempt to resolve these rental problems, staff has proposed and the lessees have agreed to the following:

For Lease PRC 745, the annual rental amount is to be \$2,826. However, if the

Department of Fish and Game places, restrictions on the sport and commercial fishing season limiting the season to less than the period extending from April 15 through September 30, the annual rental shall remain at \$1,500;

For Lease PRC 5254, the rental charges shall be based on five percent of gross income with a minimum annual rental of \$1,000.

Therefore, staff recommends that a Supplementary Letter of Understanding be executed amending Lease PRC 745 with rental charges to be changed as stated in Exhibit. "B" and that Lease PRC 5254 be terminated and a replacement lease be issued based on percentage of gross income.

- Z. Termination and Replacement of the State so Lease PRC 5254 2s for administrative purposes only, and does not change or enlarge the estate or use from that granted in the original lease.
- 3. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (14 Cal. Adm. Code 15061), the staff has determined that this activity is exempt from the requirements of the CEQA because the activity is not a "project" as defined by CEQA and the State CEQA Guidelines in that there will be "no change in the physical environment" and in that the proposed lease term will not extend beyond the existing lease term.


