AWARD OF ROYALTY OIL SALES CONTRACT, STATE OIL AND GAS LEASE PRC 3120, SOUTH ELWOOD OFFSHORE FIELD, SANTA BARBARA COUNTY -

On February 28, 1985 the Commission authorized the competitive bid sale of royalty oil produced from State Oil and Gas Lease PRC 3120. South Elwood Offshore Field. The royalty oil is currently being purchased by PRI of Hawaii, Inc. under a contract which will expire on January 1, 1986. The State's share of royalty oil produced from State Oil and Gas Lease PRC 3120 is approximately 1,400 barrels per day of 20,00 API gravity crude oil.

On April 22, 1985, the staff offered by competitive public bid the royalty production from State Oll and Gas Lease ARC 3120. Attached as Exhibit "A" is a list of the bidders and their bonus bids in dollars per barrel above the base price. The base price is the highest price posted for like crude oll in the South Elwood Offshore Field on the day of delivery.

The Commission staff has reviewed the financial ability of the bidders to fulfill the obligations of the contract and their physical ability to take the oil, and has determined the highest responsible bidder which is identified on Exhibit "A". The contract, if awarded, will be for a term of 15 months, with delivery commencing on January 1, 1906. Delivery of the oil will be by exchange agreement without any change in the existing only production and transportation facilities.

OTHER PERTINENT INFORMATION:

Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (14 Cal. Adm. Code: 15061), the staff has determined that this activity is exempt from
