OTHER PERTINENT INFORMATION: The City's letter dated April 1, 1985 notifying the Commission of its intent to spend in excess of \$50,000 of its tideland oil revenues for this capital improvement project is in conformance with the requirements of Chapter 138/'64 1st E.S., Section 6(h). Action 1 is recommended because Section 6(c) provides for "The construction, reconstruction ... recreational facilities, landscaping, parking lots and other improvements ... "and ... of Section 6(d) provides for "The construction, reconstruction ... of small boat harbors ... and related facilities all ".... on or adjacent to the long Beach tidelands ... for the benefit and use of said tidelands" Sections6(f) provides for all rethe rendition of services reasonably necessary toothe carrying out of the foregoing uses and purposes" in this case, the engineering costs of the project. The staff also recommends that the Commission's finding include a requirement that the City file a statement of final project costs with the Commission within 180 days after completion of the work, to ensure timely auditing of accounts.
