AUTHORIZATION FOR PREPARATION AND PROCESSING OF A STATE PATENT TO BE ISSUED TO SHERMAN U. DARBEE

Valley Health Care Corporation and T. J. Nelson and Associates have requested that a state patent be issued for 120 acres of Lieu land in Lake County. A fully paid Centificate of Punchase was issued to Sherman U. Darbee on November 10, 1893. Ampatent to this land was not issued because the property was not transferred to the state from the Federal government until 1902. The original Certificate of Punchase is beyond the control of the current land owner, Valley Health Care Corporation. (Nov 2) to the chain of title to the current owners a patent be issued in the name of Sherman U. Darbee the original century purchaser.

Staff has examined the file and other information submitted by the current owner and has concluded that the laws relating to issuance of a patent have been complied with, and that the person to be named in the patent, Sherman U. Darbee, is entitled to it.
