STATE INDEMNITY SELECTIONS

Staff has identified seven parcels of federally-owned land and mineral interests that have potential for production of oil, gas and geothermal steam in Solano, Sonoma, Lake, Santa Barbara, and Kern Counties. The land and mineral interests on the seven parcels to be acquired are proposed to be filed in four separate selection applications with the Bureau of Land Management.

Staff proposes to use a value for value basis in assigning indemnity base for the federal property.

It is anticipated that approximately 1,400 acres of mineral base would be used in the selections. Final acreage and values to be used will be determined by appraisals to be completed in the near future.


