APPROVAL OF A TEN-YEAR DREDGING PERMIT

APPLICANT: Eureka Forest Products, Inc.
P. O. Box 3457
Eureka, California 95502-3457

AREA, TYPE LAND, LOCATION: Tide and submerged lands granted to the City of Eureka, mineral reserved to the State, in the bed of the North Channel, Humboldt Bay, Humboldt County.

LAND USE: Excavation by dredge of up to 30,000 cubic yards of material for maintenance dredging at the Eureka Forest Products loading dock in the City of Eureka.

TERMS OF PROPOSED PERMIT: Ten years from June 1, 1985, to May 31, 1995. Consideration: A royalty of \$0.25 per cubic yard to be charged for spoils placed at an approved upland disposal site near Fieldbrook, on the property location described as the North Line of the S 1/2 of the SE 1/4 of Sec. 15 T7N R1E HBM.

BASIS FOR CONSIDERATION: Pursuant to 2 Cal. Adm. Code 2003.

PREREQUISITE CONSIDERATIONS, FEES AND EXPENSES Filing and extractive development fees have been received.

OTHER PERTINENT INFORMATION:

1. Eureka Forest Products, Inc. has applied to the State Lands Commission for a dredging permit to allow the removal of up to 30,000 cubic yards of sediments from the bed of Humboldt Bay to maintain safe navigation and accessibility to the Eureka Forest Products loading dock. Material will be placed at an approved upland disposal site near Fieldbrook on the N line of S 1/2 of SE 1/4 Sec. 15 T7N, R1E, W8M.
2. This activity involves lands identified as possessing significant environmental values pursuant to P.R.C. 6370 et. seq. Based upon the staff's consultation with the persons nominating such lands and through the CEQA review process, it is the staff's opinion that the project is consistent with its use classification.
3. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (14 Cal. Adm. Code 15061) the staff has determined that this activity is exempt from the requirements of the CEQA as a categorical exempt project. The project is exempt under Class 4, Maintenance Dredging, 14 Cal. Adm. Code 15304(g).
Authority: P.R.C. 21084 and 14 Cal. Adm. Code 15300, and 2 Cal. Adm. Code 2905(d)(2).

IT IS RECOMMENDED THAT THE COMMISSION:

1. FIND THAT THIS ACTIVITY IS EXEMPT FROM THE REQUIREMENTS OF THE CEQA PURSUANT TO 14 CAL. ADM. CODE 15061 AS A CATEGORICAL EXEMPT PROJECT CLASS 4, MAINTENANCE DREDGING, 14 CAL. ADM. CODE 15304(g) AND 2 CAL. ADM. CODE 2905(d)(2).

2. FIND THAT THIS ACTIVITY AS PROPOSED IS CONSISTENT WITH THE USE CLASSIFICATION DESIGNATED FOR THE LAND PURSUANT TO P.R.C. 6370 ET SEQ.

3. AUTHORIZE THE STAFF TO ISSUE TO EUREKA FOREST PRODUCTS, INC. THE DREDGING PERMIT ON FILE IN THE OFFICE OF THE STATE LANDS COMMISSION, SAID PERMISSION SHALL BE ISSUED IN CONSIDERATION OF A ROYALTY OF \$0.25 PER CUBIC YARD TO BE CHARGED FOR SPOILS PLACED ON THE APPROVED UPLAND DISPOSAL SITE ON PRIVATE PROPERTY NEAR FIELDBROOK. SAID PERMIT SHALL ALLOW FOR A MAXIMUM OF 30,000 CUBIC YARDS OF SAND, SILT, CLAY AND GRAVEL; EXCLUDING ALL OTHER MINERALS INCLUDING BUT NOT LIMITED TO OIL, GAS AND GEOTHERMAL FROM AN AREA OF TIDE AND SUBMERGED LANDS GRANTED TO THE CITY OF EUREKA (MINERALS RESERVED TO STATE), IN THE NORTH CHANNEL OF HUMBOLDT BAY AT THE EUREKA FOREST PRODUCTS DOCK, HUMBOLDT COUNTY AS DESCRIBED IN EXHIBITS "A" AND "B" ATTACHED HERETO AND BY THIS REFERENCE MADE A PART HEREOF. MATERIALS DREDGED SHALL BE DEPOSITED ON DISPOSAL SITES APPROVED BY ALL APPLICABLE REGULATORY AGENCIES.

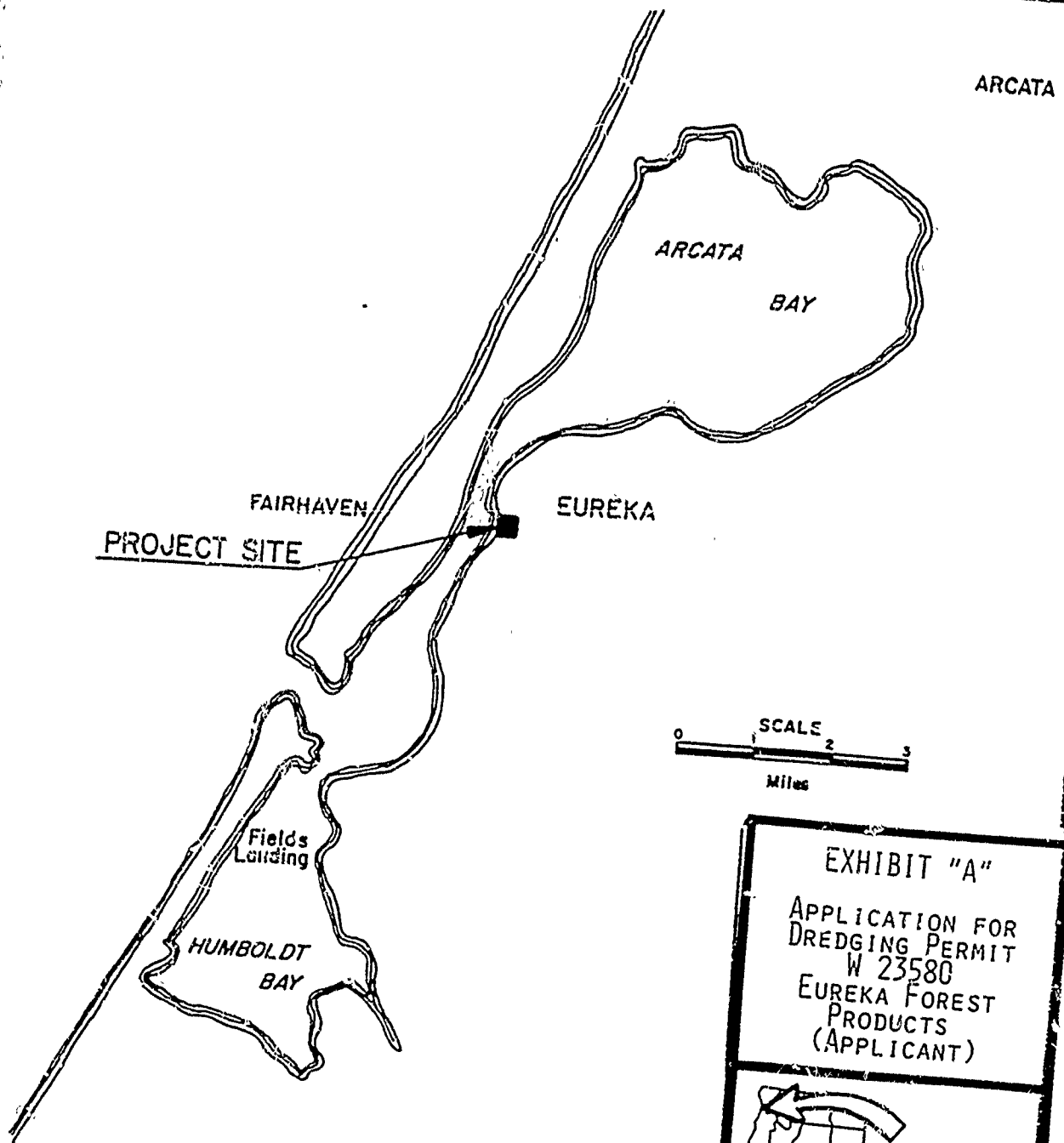

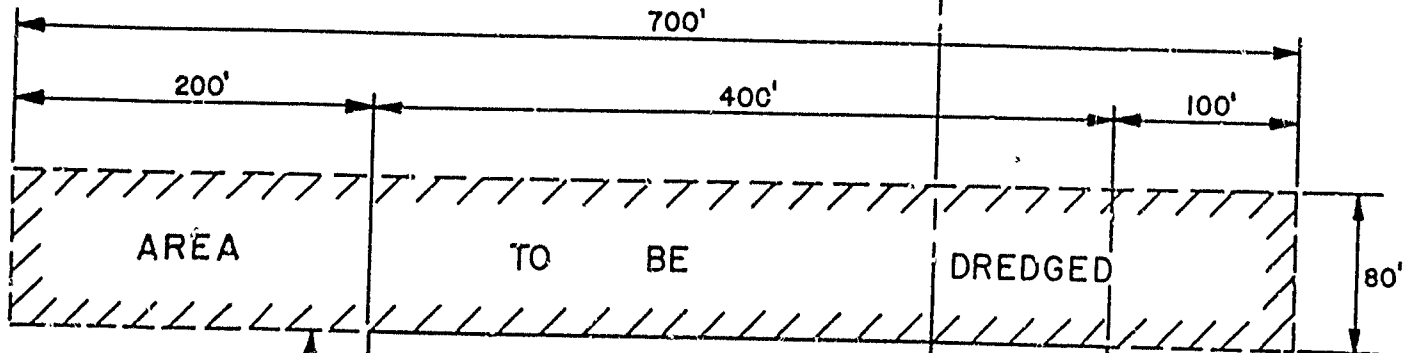
