OTHER PERTINENT INFORMATION:

- 1. On September 25, 1984, under Minute
 Item C12, the Commission approved the terms
 of amendment of lease PRC 2546 as described
 herein. The unresolved bond matter
 discussed below, however, prevents final
 issuance of the necessary implementing
 amendment document.
- 2. The principals of Crockett Marine Service,
 Inc. have been unable to provide the
 required \$100,000 surety bond, and the
 lease amendment, therefore, has not yet
 been executed by the State. In
 substitution for the bond, the Lessee has
 offered to set up a special savings account
 with his banking organization. The account
 would be pledged as security for the
 performance of the lease, and would call
 for the following provisions:
 - a. An initial deposit of \$2,000.
 - b. Monthly deposits into the account such that, at the close of 15 years, the principle and compound interest will accumulate to \$100,000.
 - c. That no part of the account would be released except upon the express written consent of the State Lands Commission.
- 3. Staff believes the Lessee's offer to establish the described savings account, in lieu of a bond, is an acceptable alternative and accordingly commends it for favorable consideration.
- 4. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (14 Cal. Adm. Code 15061), the staff has determined that this activity is exempt from the requirements of the CEQA under the general rule that CEQA applies only to projects which have the potential for
