SECOND MODIFICATION OF THE 1985-86
PLAN OF DEVELOPMENT, OPERATIONS AND BUDGET,
LONG BEACH UNIT, WILMINGTON OIL FIELD,
LOS ANGELES COUNTY

The City of Long Beach has requested approval of the Second Modification of the 1985-86 Plan of Development, Operations and Budget, Long Beach Unit. This modification would transfer funds between two Budget Items in different Budget Programs. The total adjusted budget would remain unchanged at \$229,340,000.

The Second Modification provides for the relocation of THUMS' office facilities from the harbor area to downtown Long Beach. TYUMS now has personnel at two locations in the harbor in addition to the main office. Efficiency would improve if all office personnel were in the same building.

Better quarters are available in modern buildings at a cost within 5 percent of THUMS current rental and maintenance expense. The estimated \$100,000 required for the move would be provided by transfer of funds budgeted for the replacement of carpet and drapes at the present location.

Upon approval this modification transfers \$100,000 from Budget Item 8.5.b.(5) Leasehold Maintenance to Budget Item E.1.5.(6) General Office Expense.
