AUTHORIZATION FOR PREPARATION AND PROCESSING
OF A STATE PATENT TO BE ISSUED TO
JANETTE C. PIERSON

W. M. Beaty and Associates, Inc., the contract manager for the estate of Brooks Walker, have requested that a State patent be issued for 200 acres of State school land in Lassen County. A fully-paid Certificate of Purchase was issued to Janette C. Pierson on September 22, 1903; however, a State patent was never issued for this property. The original Certificate of Purchase is beyond the control of the current land owner, the Estate of Brooks Walker. To complete the chain of title to the current owner, a patent must be issued in the name of Janette C. Pierson, the original purchaser.

Staff has examined the file and other information submitted by the current owner, and has concluded that the laws relating to issuance of a patent have been complied with; and that the person to be named in the patent, Janette C. Pierson, is entitled to it.

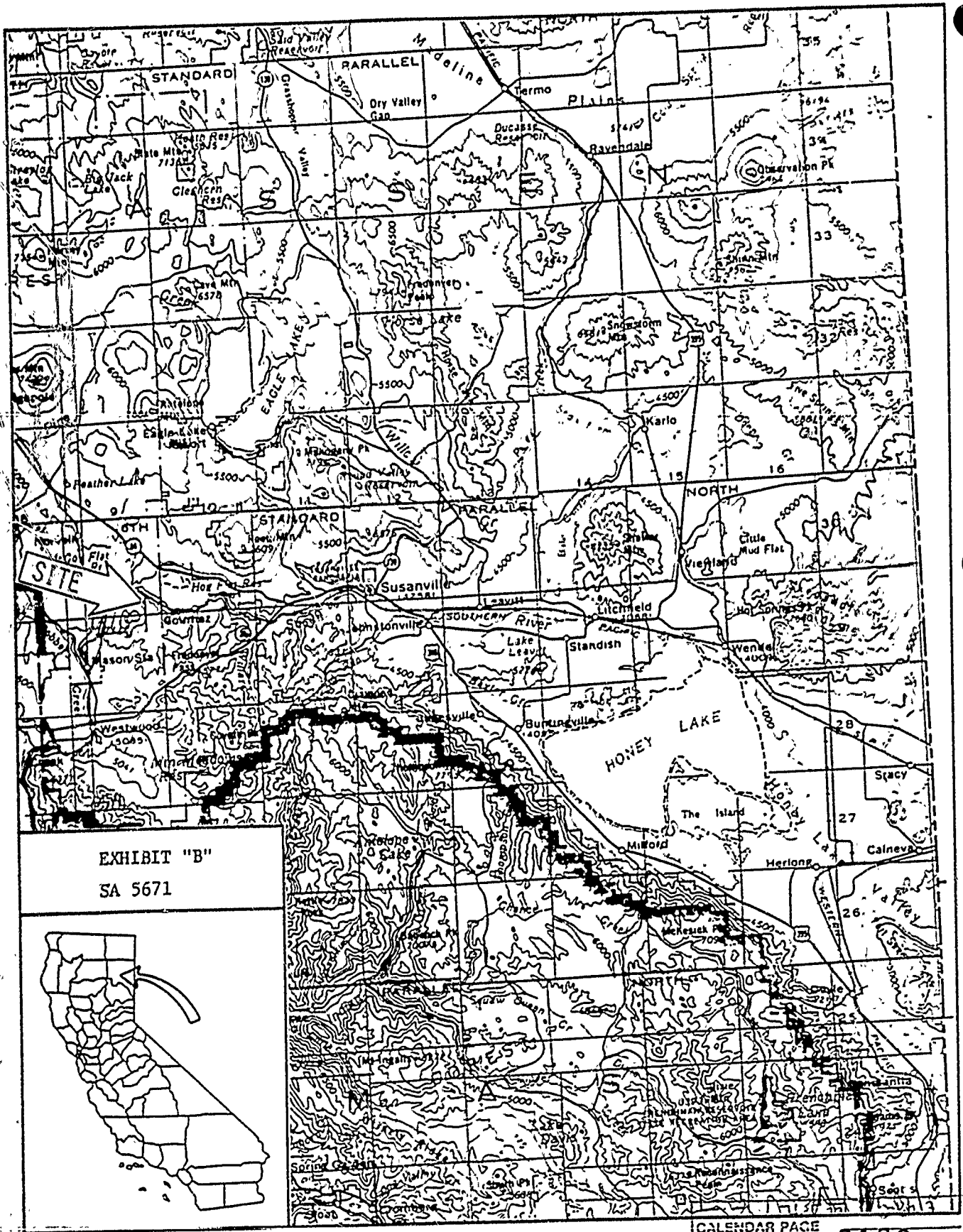
