GEOTHERMAL TEST WELL - SALTON SEA PRC 6378

THE DEEP EXPERIMENTAL GEOTHERMAL TEST WELL C PARTEL OF STATE LAND IN IMPERIAL COUNTY WAS SPUDDED ON OCTOBER 23 ..... ORDING TO OFFICIALS OF KENNECUTT CORPORATION, HOLDER OF THE STATE GEOTHERMAL PROSPECTING PERMIT.

KENNECOTT HOLDS THE PERMIT ON A 40-ACRE PARCEL OF STATE LAND ABOUT FOUR MILE'S EAST OF NILAND ON THE SOUTHEASTERN SHORE OF THE SALTON SEA. KENNECOTT IS PROVIDING THE LAND FOR TEST FACILITIES. THE PROJECT WILL BE MANAGED BY BECHTEL CORPORATION UNDER A \$5.3 MILLION CONTRACT FROM THE U.S. DEPARTMENT OF ENERGY.

THE SALTON SEA SCIENTIFIC DRILLING PROGRAM WAS ORGANIZED AS A JOINT EFFORT OF DOE, THE U.S. GEOLOGICAL SURVEY AND THE NATIONAL SCIENCE FOUNDATION TO STUDY THE DEEPER THERMAL REGIME OF THE SALTON SEA GEOTHERMAL SYSTEM THAT UNDERLIES CURRENTLY PRODUCING RESERVOIRS. THE PROGRAM WAS CONCEIVED BY UNIVERSITY AND INDUSTRY SCIENTISTS AS A FRONTIER EXPLORATION PROJECT TO DRILL DEEPER INTO THE SALTON SEA HYDROTHERMAL SYSTEM INTO MUCH HIGHER TEMPERATURE REGIONS THAN HAD BEEN PENETRATED BY INDUSTRY WELLS.

THE WELL, WHICH WILL BE DRILLED TO 10,000 FEET OR MORE TO ENCOUNTER HOT HEAVY BRINES WITH TEMPERATURES PROBABLY IN EXCESS OF 6000 FARENHEIT, IS DESIGNED TO ADD TO THE SCIENTIFIC BODY OF KNOWLEDGE ABOUT THE EARTH'S THERMAL PROCESSES AND RELATED PHENOMENA AND TO TEST THE UNKNOWN REGIONS BELOW THE KNOWN PART OF THE SALTON SEA HYDROTHERMAL SYSTEM. IT IS AN ATTEMPT TO BETTER CHARACTERIZE THE U

ENERGY POTENTIAL OF THE SYSTEM. A VARIETY OF TESTS WILL BE PERFORMED DURING DRILLING AND AFTER COMPLETION OF THE WELL FOR A PERIOD OF ABOUT ONE YEAR. CURRENTLY, THE WELL IS BEING DRILLED BELOW 3, 700 FEET. NUMEROUS CORES WERE TAKEN WHILE DRILLING TO THIS DEPTH PRIOR TO RUNNING AND CEMENTING 13 3/8" CASING AT A DEPTH OF 3, 500 FEET, ELECTRICAL AND OTHER TYPES OF LOGS WERE RUN. TEMPERATURES OF UP TO 369° FAHRENHEIT HAVE BEEN ENCOUNTERED. IF A COMMERCIAL RESOURCE IS DISCOVERED, KENNECOTT, UNDER THE TERMS OF ITS PROSPECTING PERMIT, WILL HAVE A PREFERENTIAL RIGHT TO A GEOTHERMAL LEASE.
