 The Applicant proposes to attach a temporary floating dock to the columns of an existing concrete wharf approximately 50 feet upstream of Tower Bridge to moor the river cruise boat "River City Queen". By letter dated October 4, 1985, the City of Sacramento has approved this temporary arrangement, at no charge, which is subject to termination upon the City and the Commission signing a master lease agreement for the "Old Sacramento" waterfront area.

Likewise, the State's lease to the Applicant will state that its term is on a month-to-month basis and is subject to termination upon the Commission and the City of Sacramento executing a master lease agreement currently under negotiation covering the "Old Sacramento" waterfront.

The Applicant has stated that they do not require upland access to the dock and have no need to use the wharf itself. The lease provides that no use is to be made of ' e concrete wharf deck.

As the Applicant has an existing lease, PRC 4812 Metro Marina, in good standing, staff proposes to accept an endorsement on this existing \$2,000 surety bond as surety for the temporary dock.
