TO PACIFIC GAS AND ELECTRIC COMPANY
MASTER LEASE PRC 6205

APPLICANT: Pacific Gas and Electric Company

BACKGROUND

On August 26, 1982, Minute Item No. 19, the State Lands Commission approved a master lease to Pacific Gas and Electric Company (PG&E) for various electrical energy distribution facilities located throughout the State.

The master lease allows for changes and new facilities to be added by an addendum to the master lease. The lease further specifies that no filing or processing fees shall be required for minor modifications to the lease.

CURRENT SITUATIONS

PG&E has requested that a proposed overhead 12KV electric distribution line across the Kings River, Tulare County, be included in the master lease.

TERMS OF ORIGINAL LEASE:

Initial period: 30 years beginning
September 1, 1982.

Renewal options: One successive period of 15
years.

Consideration: \$6,000 per annum; five-year

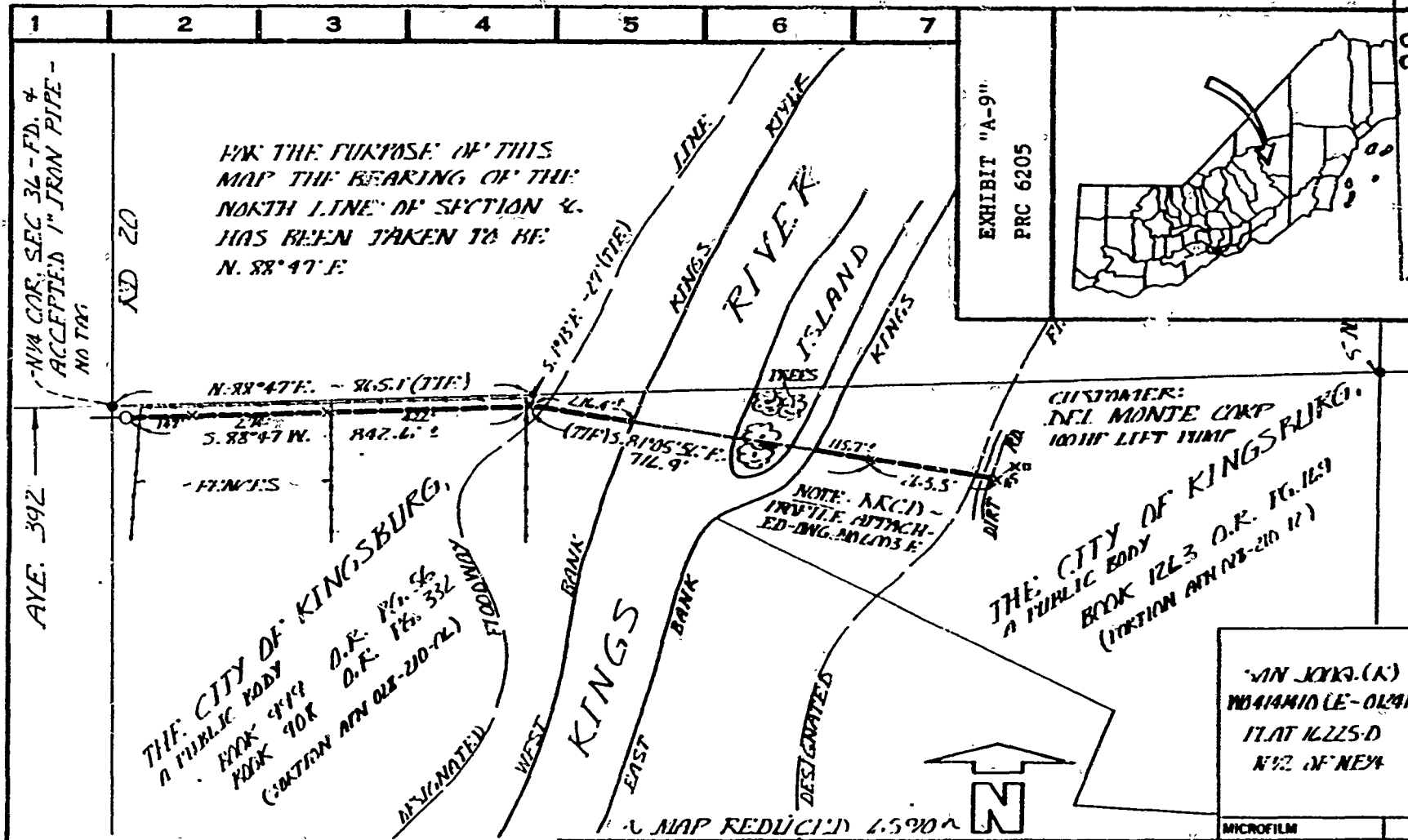

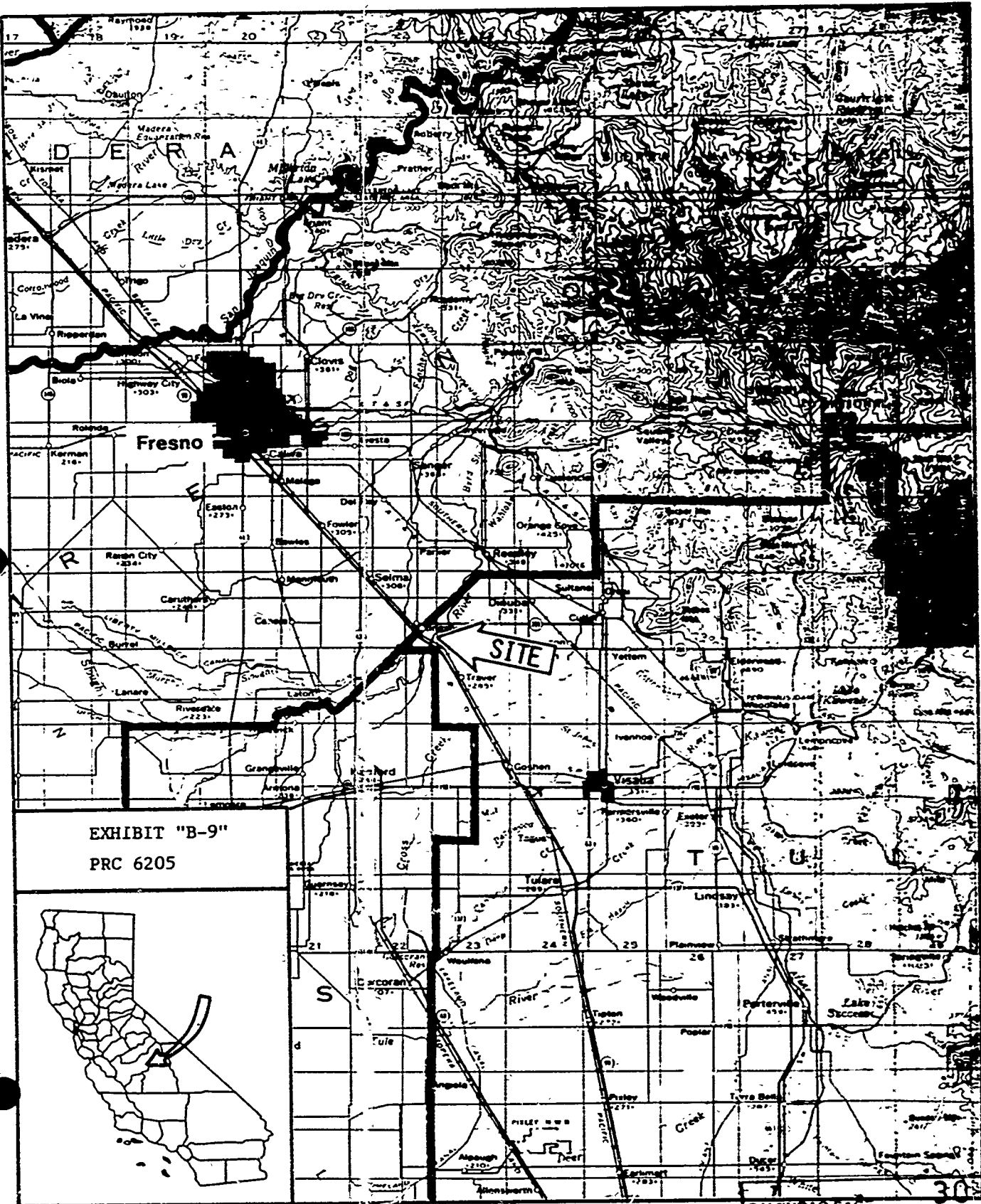
