LEASE TERMINATION AND
ACCEPTANCE OF QUITCLAIM

PARTY: Ante Zanetich
255 Golden Hind Passage
Corte Madera, California 94925

AREA, TYPE LAND AND LOCATION:
A parcel of submerged land in San Francisco
Bay, located at the intersection of 122°
28.5' west longitude and 37° 55.2' north
latitude, Marin County.

LAND USE: Use and maintenance of a mooring buoy.

TERMS OF ORIGINAL PERMIT:

Initial period: Ten years beginning
December 1, 1979.

Consideration: \$50 per annum.

BACKGROUND:

By Minute Item 2, approved by the State Lands Commission on
February 28, 1980, the State issued to Mr. Ante Zanetich a
General Permit - Recreational Use for the use and maintenance
of a mooring buoy in San Francisco Bay offshore of the Tiburon
Peninsula near Paradise Bay in consideration of \$50 per annum.

By letter dated October 12, 1984, Mr. Zanetich advised the State
that he had removed his buoy from the Bay and did not wish to
continue his lease with the State.

2. Mr. Zanetich has executed a lease quitclaim deed transferring any and all right, claim, title or interest in his leasehold, designated as PRC 5793 back to the State of California.

2. TERMINATE LEASE NO. PRC 5793 ISSUED TO MR. ANTE ZANETICH AND ACCEPT AND APPROVE A QUITCLAIM DEED FROM ANTE ZANETICH TRANSFERRING HIS INTEREST IN THE LEASEHOLD BACK TO THE STATE OF CALIFORNIA, EFFECTIVE OCTOBER 12, 1984.
