AUTHORIZATION FOR PREPARATION AND PROCESSING OF
A STATE PATENT TO BE ISSUED TO CHARLES E. LOUGH

Keith O. Truax and Siskiyou County Title have requested that a state patent be issued for the S1/2 of Section 36, T46N R1W, MDM (320 acres, more or less, of State school land), located in Siskiyou County. A fully paid Certificate of Purchase was issued to Charles E. Lough on September 28, 1907. The original Certificate of Purchase is beyond the control of the current land owner. To complete the chain of title to the current owner, a patent must be issued in the name of Charles E. Lough, the original purchaser.

Staff has examined the file and other information submitted by the current owner and has concluded that the laws relating to issuance of a patent have been complied with, and that the person to be named in the patent, Charles E. Lough is entitled to it.

OTHER PERTINENT INFORMATION:

1. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (14 Cal. Adm. Code 15061), the staff has determined that this activity is exempt from the requirements of the CEQA as a statutory exempt project. The project is exempt as a ministerial project.
