AUTHORIZATION FOR PREPARATION AND PROCESSING  
OF A STATE PATENT TO BE ISSUED TO J. FAIRWEATHER

Del Norte County Title Company on behalf of John W. Lahr and Nancy A. Lahr have requested that a state patent be issued for 80 acres of school land in Del Norte and Siskiyou Counties. A fully paid Certificate of Purchase was issued to J. Fairweather on this property. The original certificate of purchase is beyond the control of the current owner, and a patent needs to be issued to J. Fairweather, the original purchaser.

Staff has examined the file and other information submitted by the current owner, and has concluded that the laws relating to issuance of a patent have been complied with, and that J. Fairweather is entitled to the patent

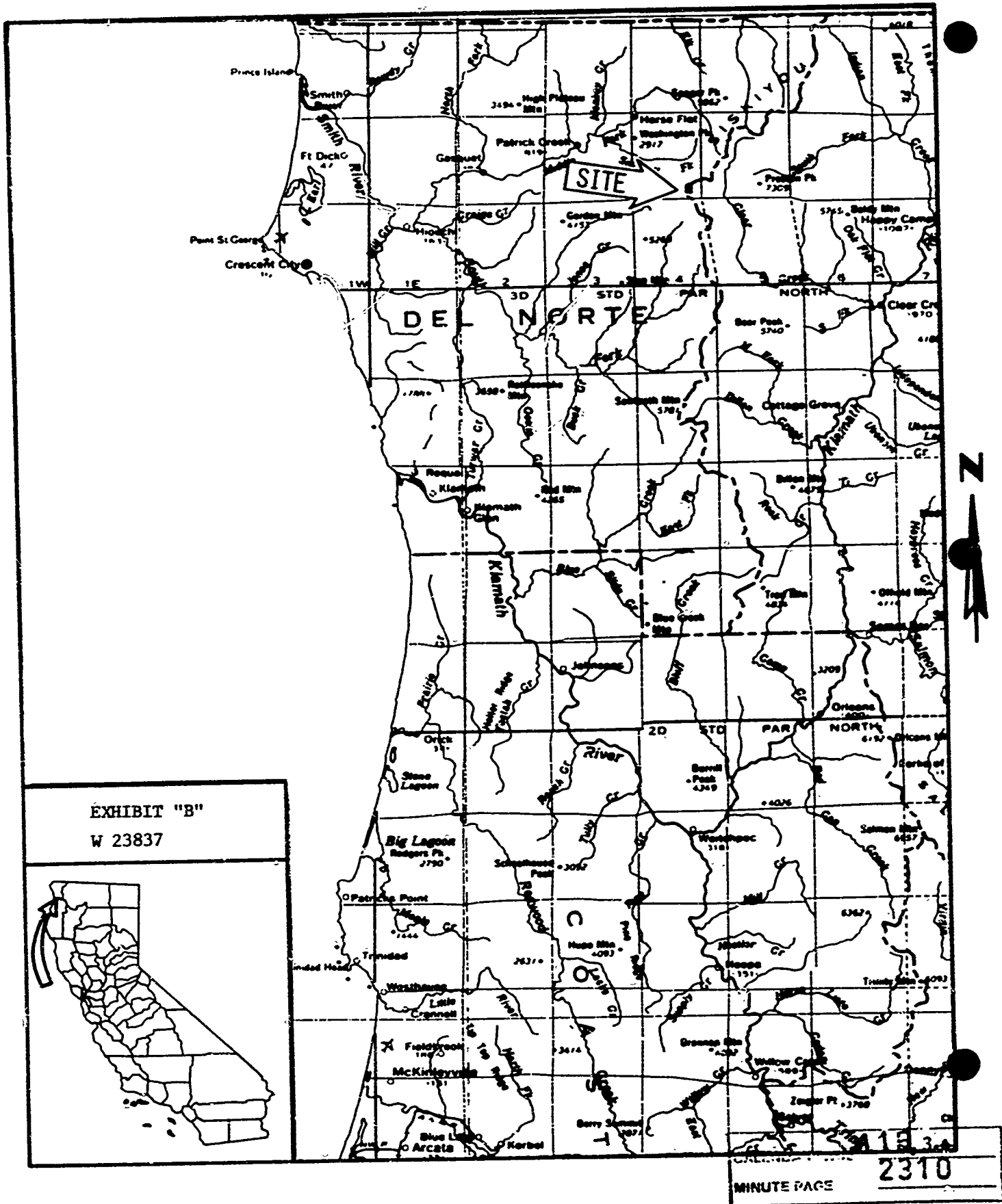
