THIRD MODIFICATION OF THE 1986-87  
PLAN OF DEVELOPMENT AND OPERATION AND BUDGET,  
LONG BEACH UNIT, WILMINGTON OIL FIELD,  
LOS ANGELES COUNTY

The Third Modification of the 1986-87 Plan of Development and Operations and Budget of the Long Beach Unit modifies the Plan and provides funding for Phase II of a liquid and contaminated drilling mud waste disposal study and environmental permitting for the cogeneration facility. The funding of \$135,000 for Budget Item E.2.b.(4), Management Projects would be provided by an augmentation of the current budget. The modified budget total would be \$137,135,000 including \$5,000 for Administrative Overhead.

Funding was not provided for the cogeneration facility in the current budget because of uncertainties about both the viability of the project with declining oil prices and actual funding required. The project remains economically viable however funding is now needed for Phase II of an expected solution to the PURPA waste heat requirements and for project permitting by the South Coast Air Quality Management District.
