AREA, TYPE LAND AND LOCATION - (PRC 4693):
Four, 14-foot radius circular parcels, an
aggregate 0.0565-acre parcel of tide and
submerged land, located in the San Joaquin
River, Antioch, Contra Costa County.

LAND USE: Four-day Beacons.

TERMS OF ORIGINAL LEASE - (PRC 4693):
Initial period: Ten years beginning August 6,
1980.

Surety bond: \$2,000.

Consideration: \$550 per annum; five-year
rent review.

AREA, TYPE LAND AND LOCATION - (PRC 1546):
A 11.838-acre parcel of tide and submerged
land, located in the San Joaquin River, at
Antioch, Contra Costa County.

LAND USE: An industrial pier and appurtenances thereof.

TERMS OF ORIGINAL LEASE - (PRC 154G):

Initial period: 20 years beginning August 9, 1980.

Surety bond: \$25,000.

Public liability insurance: \$500,000/\$1,000,000 per occurrence for bodily injury and \$100,000 for property damage.

Special: Lessee shall not be required, upon termination of this lease, to remove the fill and riprap from the lease premises, as such fill and riprap existed as of August 9, 1980. It is expressly understood, however, that such improvements shall be in good order and repair and safe condition upon lease termination.

Consideration: \$56,166 per annum; five-year rent review.

BASIS FOR CONSIDERATION:

Pursuant to 2 Cal. Adm. Code 2003.

APPLICANT STATUS:

Applicant is owner of upland.

OTHER PERTINENT INFORMATION:

1. Last year Crown Zellerbach Corporation experienced some restructuring within its company with the paper mill complex located in Antioch being placed under a newly created subsidiary, Gaylord Container Limited. On November 17, 1986, "Gaylord" was purchased by Mid America Company, however they chose to conduct business under the entity, Gaylord Container Corporation. This item is pursuant to an application being filed to assign the leases that cover State-owned lands utilized by the complex.

2. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (14 Cal. Adm. Code 15061), the staff has determined that this activity is exempt from the requirements of the CEQA because the activity is not a "project" as defined by CEQA and the State CEQA Guidelines.

Authority: P.R.C. 21065 and 14 Cal. Adm. Code 15378.

3. This activity involves lands identified as possessing significant environmental values pursuant to P.R.C. 6370, et seq. but will not affect those significant lands.

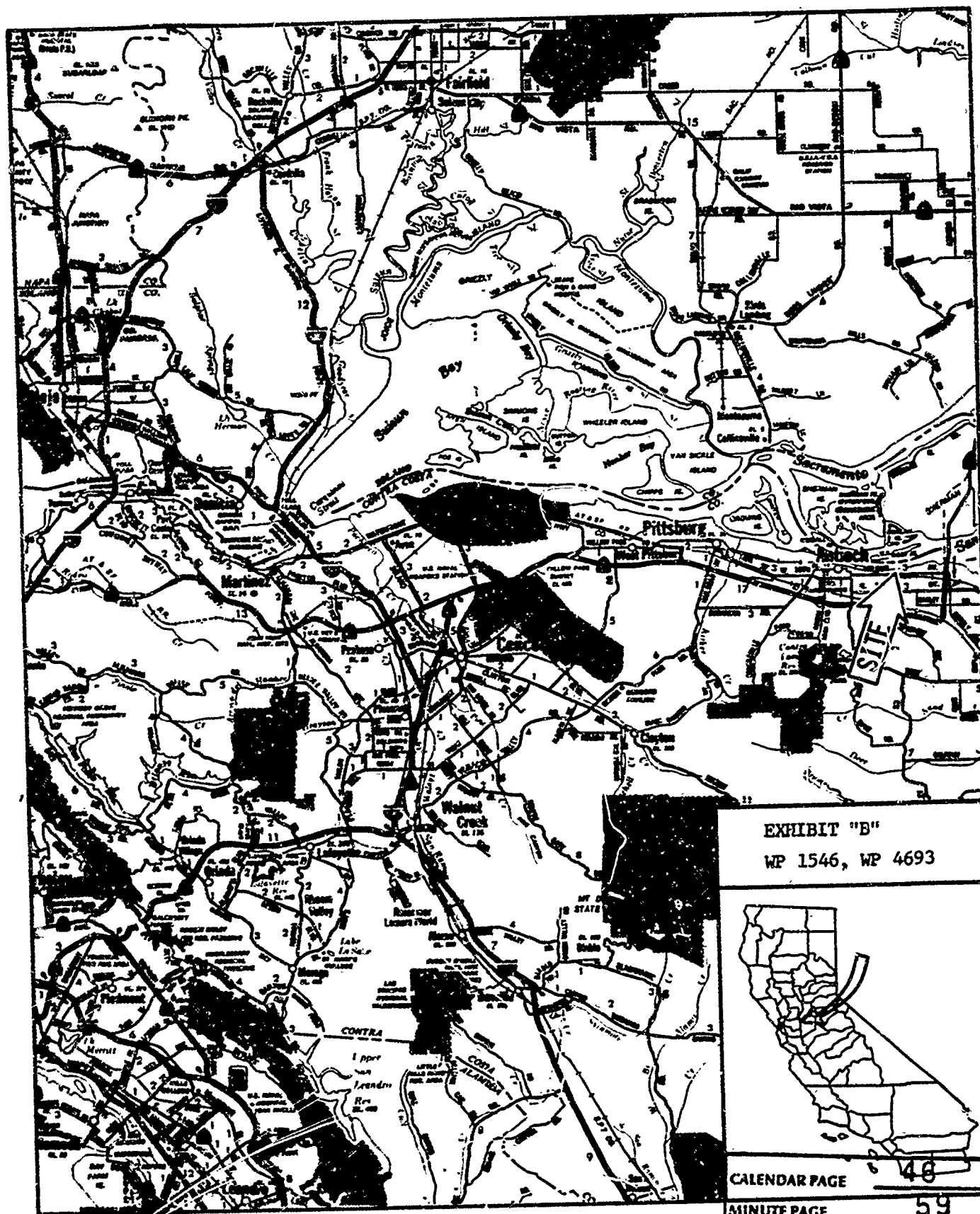
