OTHER PERTINENT INFORMATION:

- The Department of Transportation requires additional right-of-way in order to expand the existing State Route 86 to a four-lane expressway. This project incorporates design features which will increase the safety of this highway. A key element to maintaining highway safety is the controlled access to the freeway. Therefore the Department of Transportation also requires that the State Lands Commission relinquish all abutter's access rights to the freeway. The remaining State land has other legal and physical access.




EXHIBIT "C"
