At its January 31, 1985 meeting, the Commission approved a Memorandum of Agreement with the State Lessee, Ocean Front Oil Company, providing that in exchange for completion of abandonment of well "State PRC 987 Davis-11" and execution and delivery of a Lease Quitclaim Deed to State Oil and Gas Lease PRC 987, in favor of the Commission, a refund would be made to Ocean Front Oil Company of \$21,300 of disputed royalties paid under protest to the Commission.

All terms of this Memorandum of Agreement have been satisfied.

PREREQUISITE ITEMS:

1. The plug back/abandonment operations at well "State PRC 987 Davis-11" have been monitored and completed consistent with the rules and regulations of the State Lands Commission and the California Division of Oil and Gas.

- A lease quitclaim deed dated July 11, 1986, and filed with the Commission on February 20, 1987, has been duly executed by the Lessee and reviewed for legal sufficiency by Staff Counsel.
