RENT REVIEWS

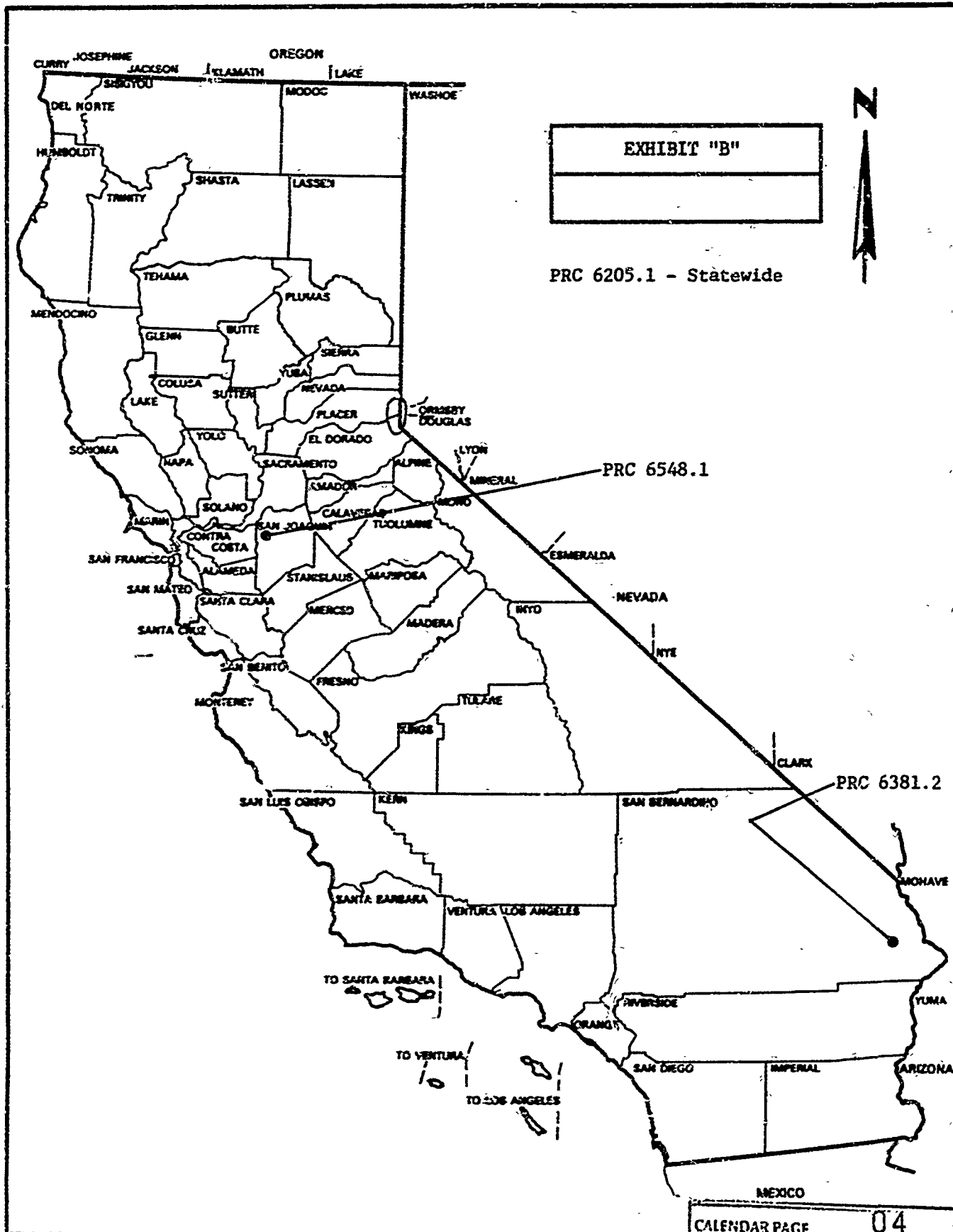
