APPROVAL OF ADDENDUM NO. 12 \* TO PACIFIC GAS AND ELECTRIC COMPANY MASTER LEASE PRC 6205

APPLICANT:

Pacific Gas & Electric Company Attn: Don Chambers 158 Peabody Road Vacaville, California 95688

AREA, TYPE LAND AND LOCATION: A 0.138 acre of tide and submerged land, Georgiana Slough, Sacramento County.

LAND USE: Overhead 21 KV electric pole line crossing.

**BACKGROUND:** 

On August 26, 1982, Minute Item No. 19, the State Lands Commission approved a master lease to "acific Gas and Electric Company" (PG&E) for various energy distribution facilities located throughout the State. The master lease, as approved, listed 82 separate leases for inclusion into the original master lease. The master lease contemplates the addition and occasional deletion of crossings according to the needs of the day. The terms of the master lease are set out below.

TERMS OF MASTER LEASE:
