BACKGROUND:

On July 24, 1986, the State Lands Commission approved the issuance of a Master Lease to the City of Sacramento covering a portion of the Sacramento River located along the waterfront in "Old Sacramento". The Commission, as part of the approval, also authorized a sublease to the Riverboat Delta King and approved a form of agreement to be used in those cases where a sublessee wishes to use its sublease for

security of a loan.

CURRENT SITUATION:

The Sublessee (Riverboat Delta King) of the City has applied to Home Federal Savings of San Diego (HOME) for a loan to reconstruct portions of the riverboat. As a condition of the loan, HOME has required that they be named as secured-party lender under the subject lease. The Master Lease provides for such an agreement, so long as the form of agreement be that attached as an exhibit to the Master Lease, and that the Commission approve the agreement.
