ASSIGNMENT INFORMATION:

Bush Oil Company has requested approval for assignment of fifty percent (50%) of its interest in State leases PRC 1961 and PRC 5968 to Tenneco Oil Company. Tenneco Oil Company is a wholly owned subsidiary of Tenneco, Inc., and authorized to conduct business in California. Bush has advised that the assignments are being requested to provide additional capital for the continued development of its State oil and gas leases.

OTHER PERTINENT INFORMATION:

- 1. Lease PRC 1961 was issued on October 23, 1957 to Richfield Oil Corporation. Through various assignments, the lease was acquired in 1987 by Bush Oil Company, a wholly owned subsidiary of Berry Petroleum Company. Lease PRC 5968 was issued on May 25, 1981 to Bush Oil Company (formerly Norris Oil Company).
- 2. PRC 1961, is a Right-of-Way for a causeway that serves to access Rincon Island, a filled island on which lessee operates State oil and gas Lease PRC 1466. Previously, the bonding requirements for Lease PRC 1961 and PRC 1466 were combined and totalled \$2,000,000 for both leases. PRC 5968 is an industrial lease for a pier which connects State oil and gas lease PRC 429 to onshore facilities. The bonding requirement for PRC 5968 is \$50,000. On September 23, 1987, the State Lands Commission approved an amendment to Lease PRC 1466 which changed the security

requirement to \$4,000,000, to be evidenced by a Letter of Credit, and covered Leases PRC 1466, PRC 410 and PRC 429. Said Letter of Credit did not reference leases PRC 19€1 or PRC 5968. In addition, the Commission approved an assignment to Tenneco of fifty percent (50%) of Bush's interest in State oil and gas Lease PRC 1466 as well as State oil and gas Leases PRC 410 and 429 on October 21, 1987.

- Lessee has agreed to amend the Letter of Credit to include Lease PRC 1961 and PRC 5968.
- Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (14 Cal. Adm. Code 15061), the staff has determined that this activity is exempt from the requirements of the CEQA because the activity is not a "project" as defined by CEQA and the State CEQA Guidelines.


