CESSION OF JURISDICTION
AT MOFFETT HOMES-ORION PARK,
NAVAL AIR STATION, MOFFETT FIELD,
SUNNYVALE, CALIFORNIA

Pursuant to Government Code Section 126, the Commission is authorized on behalf of the State to cede concurrent criminal jurisdiction to the United States upon finding:

- a. That the lands are used for federal purposes.
- b. The United States has, in writing, requested such cession.
- c. The cession is in compliance with the laws of the United States.

Under a prior cession of jurisdiction in 1980, the Department of the Navy exercised concurrent criminal jurisdiction over Moffett Homes-Orion Park, Naval Air Station, Moffett Field. Pursuant to Government Code Section 126, that cession automatically terminated on January 14, 1986. By letter dated August 20, 1987, the Department of the Navy requested that jurisdiction again be ceded for an additional five years over these same housing units.

On September 23, 1987, by Calendar Item 40, the Commission authorized the staff to conduct a public hearing on whether the cession would be in the State's best interests. The hearing was noticed in a newspaper of general circulation and the Clerk of the Board of Supervisors of Santa Clara County was served a notice of the hearing. The hearing was held on February 29, 1988. No comments regarding the cession were received at the hearing. By letter dated January 19, 1988, the Department of the Navy accepted any cession the Commission makes for these parcels.

The staff believes that cession of concurrent criminal jurisdiction is in the best interests of the State and that it will facilitate the administration of criminal law over the parcels.

  - D. IN CEDING SUCH CONCURRENT CRIMINAL JURISDICTION, THE LEGISLATURE AND THE STATE RESERVE JURISDICTION OVER THE LAND, WATER, AND USE OF WATER WITH FULL POWER OR CONTROL AND REGULATE THE ACQUISITION, USE, CONTROL, AND DISTRIBUTION OF WATER WITH RESPECT TO THE LAND AFFECTED BY SUCH CESSION.
