1988.

limit coverage of \$100,000.

EXCEPTING THEREFROM any portion lying landward of the ordinary high water mark of Tomales Bay.

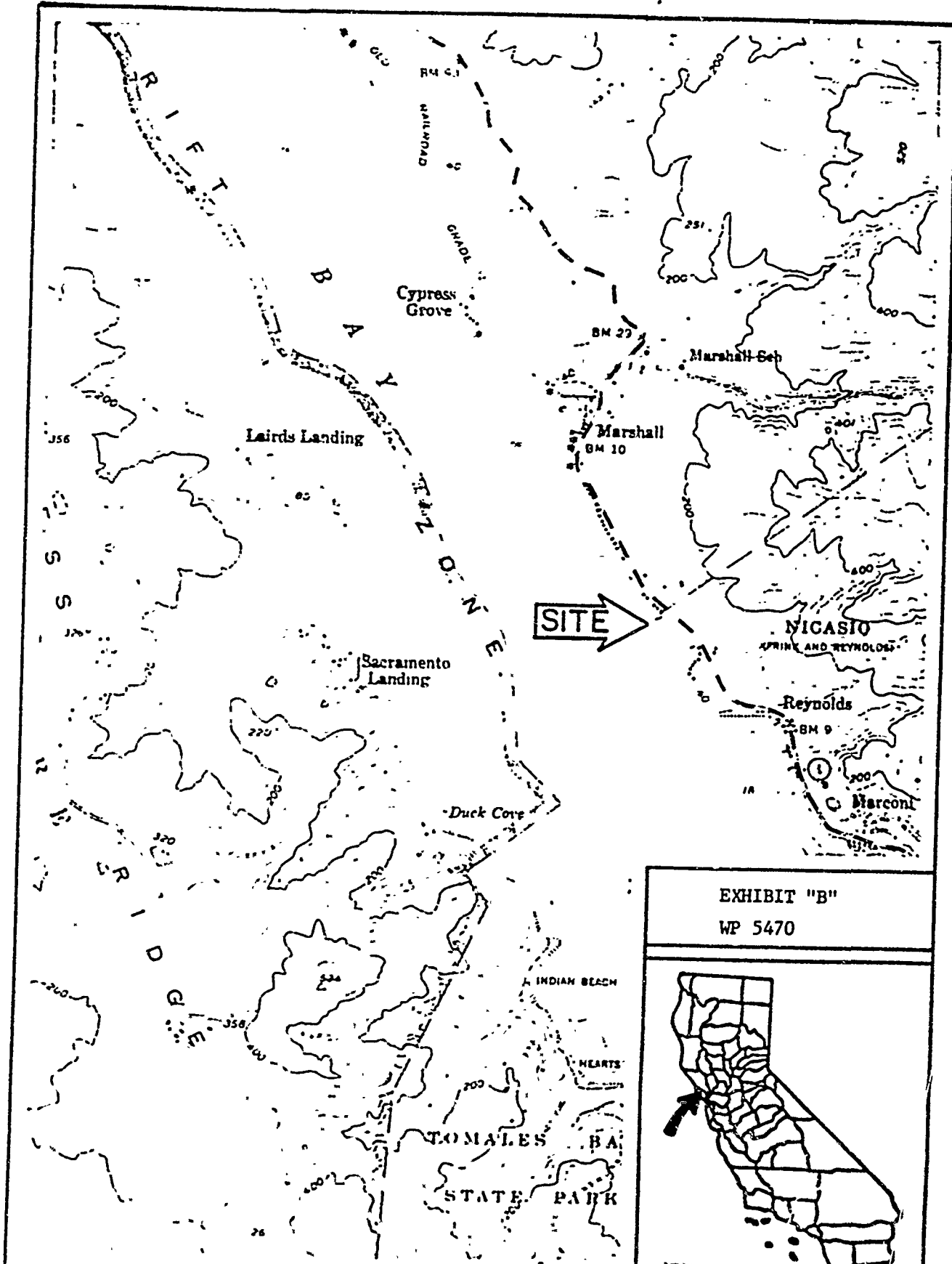
