AREA, TYPE LAND AND LOCATION:

STATE LAND: 1,885.84 acres (five parcels) of State school land approximately 35 miles north of Honey Lake, Lassen County. PRIVATE LAND: 640 acres of private land adjacent to Department of Fish and Game — Wildlife Management Area, Dakin Unit, approximately 1-1/2 miles north of Honey Lake, Lassen County.

OTHER PERTINENT INFORMATION:

1. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (14 Cal. Adm. Code 15061), the staff has determined that this activity is exempt from the requirements of the CEQA as a statutory exempt project. The project is exempt because it involves an action taken pursuant to the School Land Bank Act, P.R.C. 8700, et seq.

Authority: P.R.C. 8710.

- The Wildlife Conservation Board (WCB) 2. has requested State Lands Commission assistance in expanding the Honey Lake Wildlife Area (Dakin Unit), Lassen County. Mr. R. C. Roberts is the owner of a 640-acre parcel, adjacent to the Dakin Unit, that the WCB would like to acquire. Mr. Roberts is not interested in selling his property to WCB, but would like to exchange his property for lands under the jurisdiction of the State Lands Commission. WCB proposes the State Lands Commission exchange its acreage for Mr. Roberts' property and then WCB would purchase the State Lands Commission's (Roberts) property at fair market value.
- Staff has reviewed and approved the appraisal submitted by WCB, as to fair market value.
- 4. The consideration of \$448,000, plus accrued interest, will be deposited in the School Land Bank Fund for acquisition of lands, and to facilitate the management of school lands for the purpose of generating revenue and carrying out the goals of the School Land Bank Act, the State Lands Commission will be acting as trustee for the School Land Bank Fund pursuant to Division 7.7 of the P.R.C.

- 5. Staff has filed a General Plan for this activity with the Legislature pursuant to P.R.C. 6373.
- 6. Pursuant to PRC Section 73.03.5, staff has determined that this equal value exchange of scattered school land parcels for land will be sold at fair market value to the Wildlife Conservation Board is in the best interests of the State and is in furtherance of the legislative findings and declarations of the School Land Bank Act of 1984 (PRC Section 8702), because it disposes of scattered school land parcels that are difficult to manage and provides cash to be deposited in the School Land Bank Fund that can be used to consolidate and assemble school lands at other more economically desirable locations.






