### BACKGROUND:

On July 30, 1970. Minute Item No. 3, the State Lands Commission authorized the execution of a drillsite agreement with Coronado Cay Company and acceptance of an Easement Deed and Indenture conveying to the State rights-of-way for ingress to and egress from the drillsites. Both agreements were entered into and executed by State Lands Commission on December 28, 1970. These agreements involve lands granted to the San Diego Unified Port District, with mineral reserved to the State, pursuant to Chapter 1744, Statutes of 1965, as amended.

## CURRENT SITUATION:

Coronado Cay is developing its remaining acreage at the Cay, and wishes to abandon a portion of the existing easement lands

for ingress to and egress from the most southerly drillsite; a new easement will be substituted for that portion to be abandoned. Pursuant to paragraph 5 of the Easement Deed and Indenture, a deed substantially in the form of the present easement deed may be executed and recorded as a substitute easement and the State is to quittlaim to Coronado Cay those easement lands not within said substitute easements lands.

Staff of the Commission has reviewed the proposed substitute easement and believes it will meet the needs of the Commission for ingress to and egress from the southerly drillsite.
