AREA, TYPE LAND AND LOCATION:

Four strips of land totalling 2.41 acres,
more or less, of State school and lieu land,
located between Barstow and Mountain Pass,
San Bernardino County.

LAND USE:

Installation, operation, and maintenance of a
fiber optic communications cable.

TERMS OF ORIGINAL LEASE:

Initial period: 30 years from May 9, 1988.

Public liability insurance: Combined single
limit coverage of \$1,000,000.

Special: 1) Lessee will provide an "as
built" survey and legal
description when construction is
completed.

- 2) Lessee will provide capacity within the right-of-way to accommodate future fiber optic cables consistent with the requirements of the Bureau of Land Management, as set forth in their right-of-way grant dated April 22, 1988, with serial number: CA-20105/NV - 47888.

CONSIDERATION: \$400 per annum; with the State reserving the right to fix a different rental on each fifth anniversary of the lease.

Pursuant to 2 Cal. Code Regs 2003.

Filing fee and processing costs have been received.

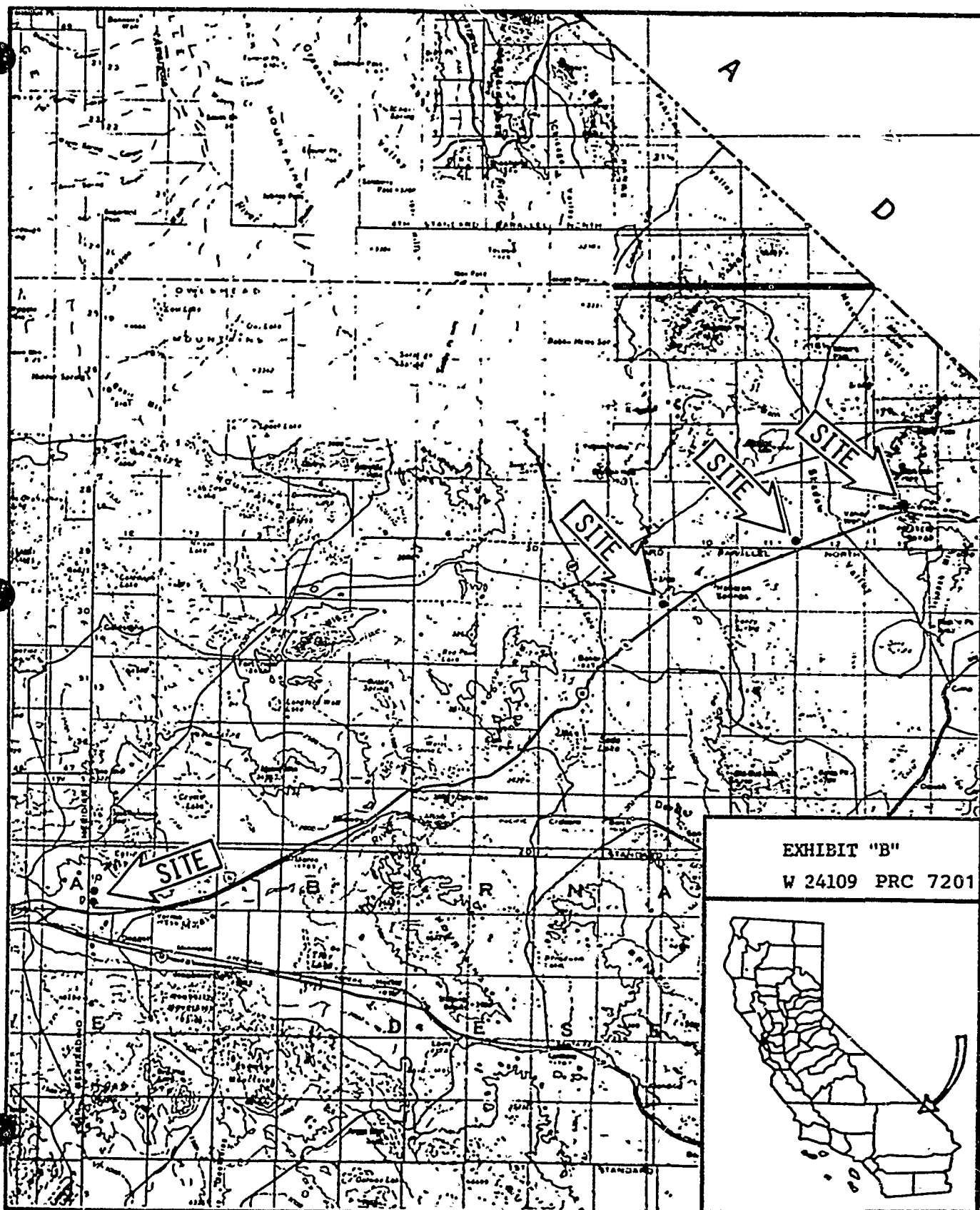
