AREA, TYPE LAND AND LOCATION:
A 0.06-acre parcel of tide and submerged land
in San Joaquin River at Webb Tract,
Contra Costa County.

LAND USE: Use and maintenance of one double, uncovered
boat berth.

TERMS OF PERMIT:

Initial period: 25 years beginning June 1,
1982.

Surety bond: \$3,000.

Public liability insurance: Combined single
limit coverage of \$200,000.

Consideration: \$182.98 per annum; five-year
rent review.

Pursuant to 2 Cal. Code Regs. 2003.

OTHER PERTINENT INFORMATION:

1. On June 29, 1982, the Commission approved a General Permit - Recreational Use for Christopher Rivers, Jr. to use and maintain one double, uncovered boat berth on the subject tide and submerged land. Mr. Rivers has since sold the upland to Neil J. Vannucci, Margaret A. Vannucci, and Nelio Vannucci, who have in turn sold the upland to Bedford Properties, Inc.

2. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (14 Cal. Code Regs. 15061), the staff has determined that this activity is exempt from the requirements of the CEQA because the activity is not a "project" as defined by CEQA and the State CEQA Guidelines.

Authority: P.R.C. 21065 and 14 Cal. Code Regs. 15378.

3. The activity is situated on lands identified as possessing significant environmental values pursuant to P.R.C. 6370.1 and is classified in a use category "B" which authorizes limited use. The project, as proposed, will not have a significant effect upon the identified environmental values.

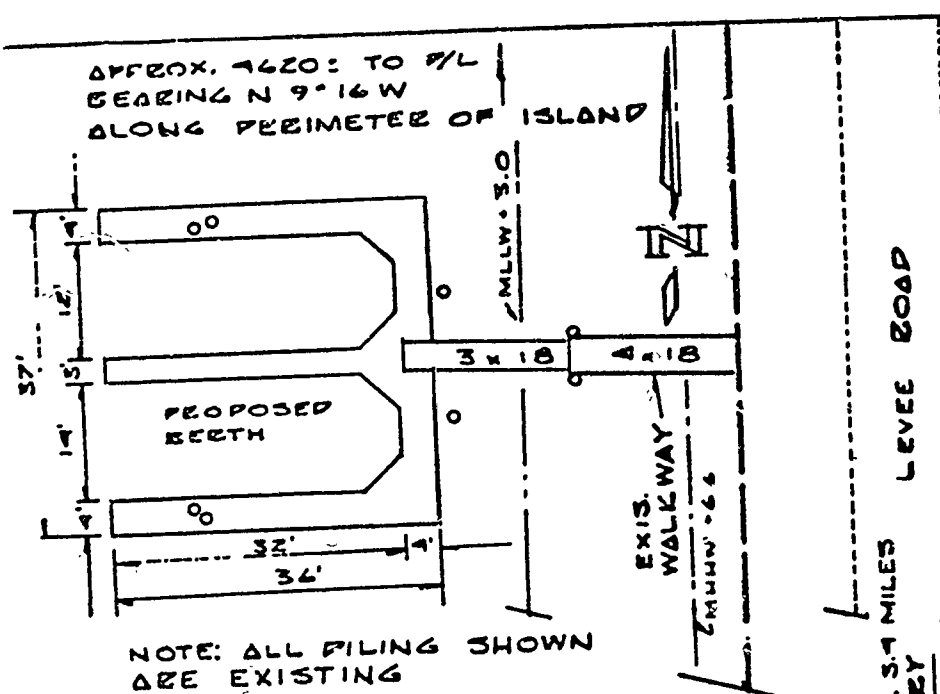
IT IS RECOMMENDED THAT THE COMMISSION:

PLAN SCALE @ 1" = 20'

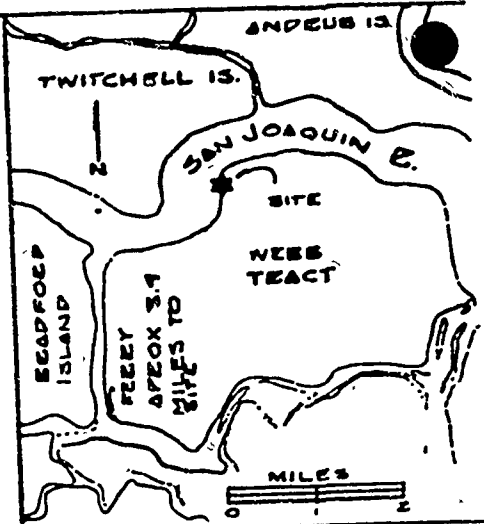

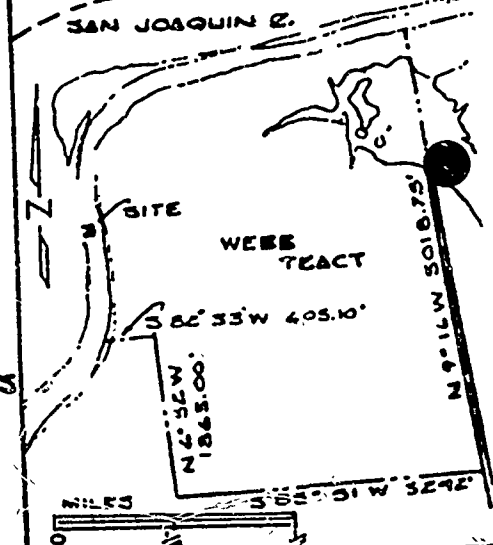

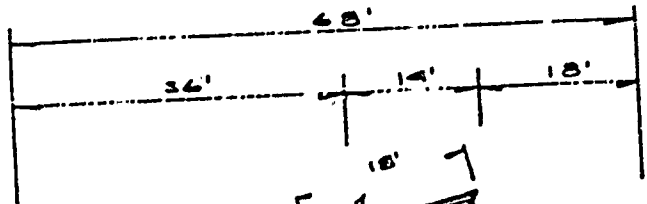

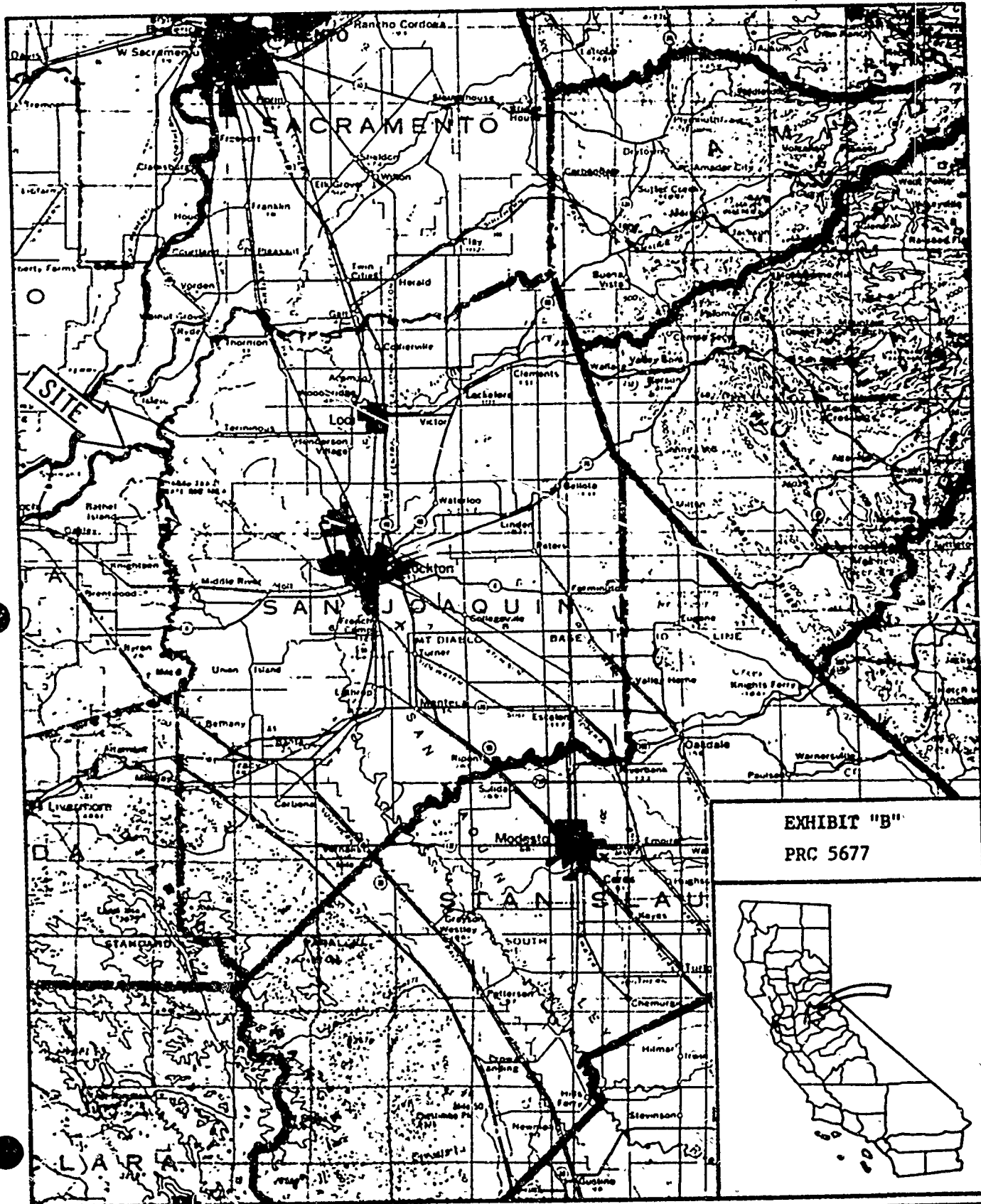
