BACKGROUND:

On December 23, 1986, the State Lands Commission approved a Boundary Line Agreement with the Santa Catalina Island Company (SCI Co.) which would result in the State having clear title to a total of 30 acres of filled tide and submerged land at Jewfish Point and Empire Landing. The Commission also approved a 49-year lease to the SCI Co., beginning January 1, 1987, for the 30 acres to which the State was receiving clear title.

Prior to Commission approval of the Boundary Line Agreement, the SCI Co. had entered into an agreement with L. G. Everist, Inc. for quarrying operations which included the 19-acre parcel at Jewfish Point and the 11-acre parcel at Empire Landing, that subsequently came under State lease PRC 7030.1.

The quarry operations cover approximately $208\pm$ acres at Jewfish Point and $218\pm$ acres at Empire Landing. There is no extraction or mining activity on the State's parcels. Materials extracted from adjacent uplands are carried by truck across the State's parcels to an existing loading facility, where they are transferred to barges for transportation to the mainland. The current agreement (called "the Quarrying Agreement") with L. G. Everist is for a term of five years beginning January 1, 1986. Annual rental is based on a royalty for extracted rock with a minimum royalty of \$50,000 per year. Insurance required under the SCI Co.'s agreement with L. G. Everist is \$500,000 per occurrence for bodily injury and \$300,000 for property damage.

SCI Co. has also entered into an Extension Option Agreement dated February 9, 1988 which gives L. G. Everist two additional options to extend the quarrying agreement through December 31, 2005.

CURRENT SITUATION:

Lease PRC 7030 provides that all subleases must be approved by the State Lands Commission. Commission staff recommends approval of the sublease in the form of the aforementioned


