- 1. At its meeting on January 26, 1978 (Minute Item No. 24), the Commission authorized issuance of a master gas pipeline lease to P.G.& E. covering their then existing 89 State Lands leases. P.G.& E. has now applied to the Commission for an amendment to the lease to add a new parcel for a 6 5/8 inch buried pipeline crossing at Hog Slough, San Joaquin County.
- Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (14 Cal. Code Regs. 15061), the staff has determined that this activity is exempt from the requirements of the CEQA as a categorically exempt project. The project is exempt under Class 4, Minor Alteration to Land, 14 Cal. Adm. Code 15304.

3. This activity involves lands identified as possessing significant environmental values pursuant to P.R.C. 6370, et seq. Based upon the staff's consultation with the persons nominating such lands and through the CEQA review process, it is the staff's opinion that the project, as proposed, is consistent with its use classification.
