#### OTHER PERTINENT INFORMATION:

Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (14 Cal. Code Regs. 15061), the staff has determined that this activity is exempt from the requirements of the CEQA as a categorically exempt project. The project is exempt under Class 4, Minor Alteration to Land, 2 Cal. Code Regs 2905(d)(2).

Authority: P.R.C. 21084, 14 Cal. Code Regs. 15300, and 2 Cal. Code Regs. 2905.

- The project area consisting of 2. approximately 500 square feet will involve the removal of small trees and brush from the bank of the river and replaced with clean rock riprap.
- The annual rental value of the site is 3. estimated to be \$50, which is the minimum rental for this type of permit.
- This activity involves lands identified as 4. possessing significant environmental values pursuant to P.R.C. 6370, et seq. upon the staff's consultation with the persons nominating such lands and through the CEQA review process, it is the staff's opinion that the project, as proposed, is consistent with its use classification.


